Executive Summary – Key Observations


- The 2010 Business Performance Reporting and Analysis study, covers general aspects of the Controlling/ FP&A service delivery model, with a particular focus on key practices and challenges in Business Performance Reporting and Business Analysis.
- **Top Performers use almost 2/3 less staff than their peers** in the Controlling/FP&A organization relative to the management community they support ("budget holders").
- Top Performers also better leverage their Controlling/FP&A professionals by focusing most of their resources on high value adding activities. Controlling/FP&A professionals at Top Performers spend 66% of time on value-added analysis vs. only 35% at peers.
- Top Performers are much more confident in the KPIs used in their reporting and the business analysis used for decision support.
- Top Performers deliver results to management faster than their peers allowing management more time to analyze business performance and make better informed, more timely decisions on future actions.
- Key practices that differentiate Top Performers from their peers include strong process ownership and governance over data and reporting standards, integrated technology extending to self-service and greater alignment around a rationalized library of standard reports.

How confident are you that the right Business Analyses are produced to support key decisions in your organization?






#2 Process control & management


Global process ownership is a clear differentiator for top 10 performers in Business Performance Reporting and Business Analysis

63% of the Top Performers have established Global Standards for all Standard Reports vs. only 16% of the peer group.



75% of the Top Performers have a medium to high degree of automation in the production of exception based ad-hoc reports vs 44% of peers.




#5 Speed of access

#6 Automation and self service


Automation and self service are the two most often cited actions that organizations are taking to improve focus and time spent on analysis


