The dynamic A&D Pharma group comprises Mediplus Exim SA, the biggest medicine wholesale distributor in Romania, and Sensiblu SRL, the largest network of pharmacies in the country.

The rapid development of the Mediplus company was the result of a concerted effort to create a flexible structure that responded promptly and professionally to customers' and suppliers' needs. In 1997 the first Sensiblu pharmacy was opened in Bucharest as an experiment to demonstrate to the Mediplus contractors the most efficient way of arranging the products in a pharmacy. The experiment was such a huge success that in the following year the number of pharmacies increased to 206.

Today, Sensiblu is still a market leader in Romania with 190 pharmacies across the country providing around the clock healthcare to patients.

# **Challenges faced**
