### **German actor Erwin** Geschonneck dies at 101

Erwin Geschonneck, German actor died Wednesday. He was 101. His biggest success occurred in the German Democratic Republic, where he was considered one of the most famous actors of the time.

He was born on December 27, 1906 in Bartenstein, Germany. In 1938, he was arrested in Prague and was imprisoned in several concentration camps. In 1945, Geschonneck was evacuated from the concentration camp Neuengamme on the boat Cap Arcona, which was subsequently attacked by the RAF and sunk. He was one of the few prisoners who survived.

Immediately following the war, Geschonneck acted in theaters in Hamburg, Germany, and made his film debut in 1947 in In jenen Tagen.

His last movie, made in 1995 for the German television network ARD, was "Matulla und Busch", where he played alongside veteran actor Fred Delmare. Geschonneck's son, Matti Geschonneck, directed.

#### Church of Scientology denied injunction against Anonymous

The Church of Scientology's second petition for an injunction against online protest group Anonymous was denied by Judge Douglas Baird. The first petition, filed Tuesday, against Anonymous was denied yesterday by Judge Linda Allan. The injunction sought to prevent members of Anonymous from coming within 500 feet of Church of Scientology buildings. At time of publishing, the Church has not responded to a request for comment.

In his ruling, Judge Douglas Baird of Pinellas County, Florida wrote: "This Petition has been filed against twenty-six individuals alleged to be associating as a group referred to as 'Anonymous'. The Petition contained no specific allegations of wrongdoing against the individuals named as Respondents, nor it is alleged that any of the said named Respondents are responsible for any threats, phone-calls, or specific wrongful acts sought to be enjoined. The Petition fails to allege that any of the Respondent have interfered with or have attempted to deprive the Petitioners of any cognizable right. Further, the Court finds that the

> Before deciding to take up the writing of fiction, Robinson was an artist and moviemaker. He says of his years before getting published, "I lived well under the poverty line.....so I could write."

Although his first book, The Didymus Contingency, was selfpublished, the following two were released through a small press. deal with St. Martin's Press, a major publisher. He said that he was "pretty excited" about this.

Robinson is currently at work on two other novels.

#### Interview

Wikinews: You've written three novels. Tell us about them. Mr. Robinson: I've actually written published, and they're all very different from each other. Focusing on the three published books; my first novel The Didymus Contingency is a time travel thriller where the main characters go back the story of Jesus, the other to stop him. My second novel, Raising the Past, is a straight forward scifi, arctic thriller that launches into action when a team of scientists discovers an alien artifact clutched in the arms of a woman...whose frozen inside the belly of a preserved mammoth. The newest of the three published, and my favorite, is Antarktos Rising. This story starts off with a global catastrophe as the Earth's crust shifts moving the North Pole to North Dakota and Antarctica (Antarktos) to the equator. 2.6 billion people die in the first few chapters and the ravaged world

turns to Antarctica as a new promised land...but the continent has already been claimed by the Nephilim-bad guys straight out of the book of Genesis.

WN: What inspires you to write? Mr. Robinson: I suppose I was born with an insatiable appetite for story telling. When I was younger I expressed this through art, and to an extent still do. I was an illustration major in college and began illustrating comics after college. But writing crept in and hooked me. It's a much satisfying way to flesh out a story and the world the characters live in-more than comics, more than movies (both of which I tried before making the final switch to novels). As far as day to day inspiration. I suppose I would say nature. The power and mysteriousness of it. Primarily the ocean. A day on the ocean can power a month of writing.

WN: What sets your books apart from the rest how are they different, unique? Mr. Robinson: I would say my ability to tackle heavy, sometimes even controversial topics in a fun way. Didymus tackles the life, death and resurrection of Jesus. Antarktos covers creationism vs. evolution, a genetic cause for Noah's flood and the account of the Nephilim in Genesis. But because I'm not writing with the intent of convert people to any idea, philosophy or religion (because I don't necessarily agree with the viewpoints of my characters-they're their own people) they don't read as being preachy or antagonistic. So I'm able to handle religious topics in mainstream thrillers that are otherwise relegated to Christian fiction-meaning they're written for Christians. I chose to write this way because I can handle topics

and concepts that are exciting while concentrating on making the pace breakneck, the plot twisting and the characters enjoyable. I don't get bogged down by trying to Here's what I did in the past ten prove a personal point of view. In my upcoming series I do the same thing, but with mythology as opposed to Biblical topics...which leads to the next question.

WN: Will you be writing another novel soon?

Mr. Robinson: I am currently writing two novels (my seventh and eighth). The first, ACHE, deals with the subject of hell, but I'm keeping the story under wraps. Don't want to kill the surprise. The second novel I'm working on now, ROUSE, is the first book in a three book series that I've just signed on Times bestseller list. It's more with St. Martins Press to write! This deal was actually just announced today, so I'm pretty excited. The series follows a team the Chess Team: King, Queen, Knight, Rook, Bishop and their handler Deep Blue. In book one they battle a terrorist-friendly biopharmaceutical company working on human limb regeneration, whose experiments unleash the pinnacle of physical regeneration-the ancient creature known as the Hydra. This is James Rollins meets Matthew Reilly. Should be a ton of fun. The first book comes out Spring/Summer 2009.

WN: Is there any advice you can give some of the authors reading this who are struggling with their writing?

Mr. Robinson: There is a lot of stereotypical advice for this question. Some say write a page a day. Some say to have someone other than your mother critique my experience has taught me that a ridiculous amount of

commitment can make big things happen. When I wrote my first fiction it was abysmal. Absolute garbage. That was ten years ago. years to get to my St. Martin's deal. Wrote six novels. Wrote twenty-something short stories. Wrote thirteen screenplays. Interned at an agency. Selfpublished the first edition of Didymus Contingecy. Went with a small press for the next two. Rewrote the majority of all the previous writing several times. That's really an insane amount of work, the majority of it not making me a dime. I lived well under the poverty line for years so I could write. The point is, do not expect to write a novel, sell and hit the NY likely you'll spend the next ten years trying...and that's if you spend 30 - 40 hours a week on your writing like I have. If you really want it and can't imagine doing anything, you'll enjoy the process...though perhaps not the Ramen Noodles. My only other advice is to become a master at marketing and selfpromotion. ## **H5N1 Avian Flu virus has** mutated, study says

Researchers involved in a study at the University of Wisconsin have discovered that the H5N1 Avian Flu virus has mutated into a strain that may make humans more vulnerable to the disease.

Prior to the study, it was known that the virus could only thrive or live in a body which have temperatures of 106°F (41°C). A your work. It's all good advice. But human's normal body temperature is 98.6°F (37°C). This difference in the temperatures of bodies makes

the virus less likely to infect a human, but the recent study suggests the virus has adapted to survive in bodies with temperatures lower than 106°F.

"We have identified a specific change that could make bird flu grow in the upper respiratory tract of humans," said Yoshihiro Kawaoka, the researcher in charge told the press that "A man was of the study.

Kawaoka also stated that the "viruses that are circulating in Africa and Europe are the ones closest to becoming a human virus," but also stated that the H5N1 virus must undergo several mutations before it can infect a human, who can then spread the virus to other humans.

"Clearly there are more mutations that are needed. We don't know how many mutations are needed for them to become pandemic strains," added Kawaoka.

The World Health Organization (WHO) has stated that despite the study, influenza viruses are constantly mutating from season to season, but that the H5N1 virus is not anymore deadly to humans than before the study.

"Mutations occur in influenza viruses. Separately from that, the (bird flu) virus continues to be deadly. But there is no new jump in deadliness," said Gregory Hartl, a spokesman for the WHO.

#### Man breaches security at **London's Heathrow Airport**

At around 14:00 UTC today, a man climbed over the perimeter fence and made his way onto the North runway, 27R, at London's Heathrow Airport, the United Kingdom's largest airport. The man, who was carrying a rucksack, then attempted to run in to return to normal later this

## Atlas V successfully launches spy satellite

An Atlas V rocket has successfully Reconnaissance Office (NRO). ## Australian Senator arrives at Parliament dressed as a beer bottle

Family First Senator Steve Fielding arrived at Parliament today, awareness of a bill he intends to move in the Senate today. Senator establish a nationwide refund scheme for bottles and cans.

Family First wants a rebate of 10 cents per container, while the Australian Greens want 20 cents.

parliament dressed as a beer bottle, the Senator said the legislation would reduce litter by 25 per cent. "There's a message in this bottle."

"I am no longer trash, I'm cash."

"We should get the litter off the streets and off the creeks and into recycling - that's good for the environment and good for the community"

"It's a win-win and I can't understand why nationally we don't have a scheme," said Senator Fielding.

Senator Fielding said that recycling and former state senator Gary not only reduced litter, but also consumes less energy than making new containers from scratch. "Recycling a plastic bottle saves more than 80 per cent of the energy used to make a bottle from scratch and recycling aluminium cans uses just five per cent of the energy used making a can from scratch," said the Senator.

Senator Bob Brown, leader of the Greens said while there were environmental benefits from recycling, it would also create thousands of new jobs.

"This is a very good way of recycling and reducing energy because a lot of energy goes into making cans and bottles," Senator Brown told reporters.

"It will employ tens of thousands of people across Australia."

# **Assisted-suicide doctor Jack** Kevorkian to run for US Congress

Dr. Jack Kevorkian, a prominent United States advocate for the right-to-die for terminally ill patients via physician-assisted suicide, stated on Wednesday that he intends to run for a seat in the United States House of Representatives.

"We need some honesty and sincerity instead of corrupt government in Washington," Dr.

Kevorkian said while announcing his bid to represent Michigan's 9th congressional district. He said more information about his candidacy would be forthcoming next week, but he will run without party affiliation.

This seat is currently held by Congressman Joe Knollenberg, a Republican who has been the incumbent since 1993. Democrat Peters is also contesting the seat.

Kevorkian told The Oakland Press of Pontiac, which broke the story, that his campaign was in a "formative stage". In order to be on the ballot, Kevorkian will need to collect 3,000 signatures by the middle of July.

"That will be very easy for Jack," said Ruth Holmes, a long-standing associate of Kevorkian. "Jack is in great spirits, and he intends to do this. He just hopes for some honesty in government," she said.

Mike Brownfield, the campaign manager for Knollenberg said it "doesn't affect Joe Knollenberg at all. He's going to keep getting things done for Oakland County's families."

Julie Petrick, spokesperson for the Peters campaign, said "anybody has the right to run" but this is "one of the top races in the country as far as viability and our ability to win here."

Oakland County prosecutor Dave Gorcyca, whose office got Kevorkian convicted of seconddegree homicide in 1999, said, "To Jackson. call attention to himself is standard protocol for Jack when he Ms Jackson said the HSU offered doesn't have the limelight focused on him. I would not consider his candidacy to be a legitimate one."

Kevorkian served eight years of a 10-to-25 year prison sentence. He was released in June of 2007 on parole due to good behavior.

#### Australian health workers to close intensive care units in Victoria next week

Members of Australia's Health Services Union (HSU) will go on strike in Victoria next week in a dispute over stalled wage and career structure negotiations. Over 5000 physiotherapists, speech pathologists and radiation therapists will walk off the job next week, effectively closing the state's 68 largest health services.

The strike will force the closure of intensive care units and emergency departments across the state.

It is feared the strike could continue into Easter.

National secretary of the HSU, Kathy Jackson said admissions would be crippled, while intensive care patients would have to be evacuated to New South Wales, Tasmania and South Australia as hospitals will not be able to perform tests or administer treatment.

"When an ambulance shows up you can't admit a patient without an X-ray being available, you can't intubate them and you can't operate on them," she said.

"If something goes wrong in an ICU you need to be able to X-ray, use nuclear medicine or any diagnostic procedure," said Ms

arbitration last year, but the state government refused. "They're not interested in settling disputes, they hope that we are just going

to go away."

"We're not going away, we've gone Victorian Hospitals Industry back and balloted the whole public Association industrial relations health workforce in Victoria, those ballots were successful, 97 percent said hospitals were looking at the approval rating," she said.

The HSU is urging the government to commence serious negotiations to resolve the dispute before industrial action commenced.

The government has offered the union a 3.25 per cent pay increase, in line with other public sector workers but the union has demanded more, but stopped short of specifying a figure.

Victorian Premier John Brumby said the claim would be settled according to the government's wages policy. "The Government is always willing and wanting to sit down and negotiate with the relevant organisations . . . we have a wages policy based around an increase of 3.25 per cent and, above that, productivity offset," he told parliament.

The union claims it is also arguing against a lack of career structure, which has caused many professionals to leave the health service. Ms Jackson said wages and career structures in Victoria were behind other states.

Victorian Opposition Leader Ted Baillieu said he was not in support of the proposed strike and called on the government to meet with unions. "There could not be a more serious threat to our health system than has been announced today."

"We now have to do whatever is possible to stop this strike from proceeding," he said.

The opposition leader will meet

with the union at 11:30 AM today.

#### Jimmy Wales accused of editing for donations

Wikipedia founder Jimmy Wales has been accused of editing pages in the encyclopedia in return for a donation to the Wikimedia Foundation. In an article published Tuesday, the Sydney Morning Herald reported that former Novell computer scientist Jeff Merkey alleged Wales had made edits to his article on his behalf, in exchange for a donation to the Wikimedia Foundation. The news hit the website Slashdot later Tuesday, where the incident was dubbed "DonorGate".

Merkey claims that he was told by Wales in 2006 that the Wikipedia article about him could be made more favorable in exchange for a donation. Merkey made a donation of USD\$5,000 to the Wikimedia Foundation, and Wales made edits to the Wikipedia article about Merkey around the same time. Merkey published his claims on a public Wikimedia mailing list and sent a statement to The Associated Foundation's Head of Press.

"Of course I would never offer, nor accept any offer, whereby a donation would buy someone special editorial treatment in the encyclopedia." —Jimmy Wales

In a response Wales called Merkey's statements "nonsense", saying "Of course I would never offer, nor accept any offer, whereby a donation would buy someone special editorial

treatment in the encyclopedia. I do routinely assist people with WP:BLP issues, and I do courtesies for many people. Donations have no bearing on that at all." WP:BLP refers to Wikipedia's policy regarding biographies of living persons on the encyclopedia.

After deleting the Wikipedia article about Merkey in 2006, Wales wrote to Wikipedia editors he had done so "because of the unpleasantness of it" and requested that they "be extra careful here to be courteous and assume good faith". After erasing the article, Wales placed the article under protection with editing access limited to established users. Merkey ceased his \$5,000.00 per year payments to the Wikimedia Foundation after reviewing what he called "evidence of diversion and mismanagement of the charities funds by Wales and the Wikimedia Board of Trustees".

"The Wikimedia Foundation, its staff and board members, and the users of Wikipedia itself hold the core principles of 'no conflict of interest' in the highest regard." —Jay Walsh, Wikimedia Foundation

In a statement responding to a post about the incident on the site Techtree.com, Wikimedia Communications Jay Walsh addressed the Foundation's principles regarding conflict of interest: "The Wikimedia Foundation (the Foundation which operates and maintains Wikipedia and other free knowledge projects) has never solicited or accepted donations for the purposes of making edits or offering protection to Wikipedia articles. Nor has Jimmy Wales ever solicited or accepted donations for the Foundation in this capacity. These

allegations are completely false. ... Jimmy has been unfailingly ethical and frugal in the use of all Foundation funds. The Wikimedia Foundation, its staff and board members, and the users of Wikipedia itself hold the core principles of 'no conflict of interest' in the highest regard."

After leaving Novell amidst allegations of misappropriation of trade secrets, Merkey was sued by his former employer. He filed a harassment lawsuit against organizations including the website Marsden opened an auction for Slashdot in 2005. Merkey filed a suit against Delta Air Lines and Natural Selection Foods in 2006, claiming his son had become sick from E. coli contaminated spinach.

Merkey is banned from editing Wikipedia due to a ruling by Wikipedia's Arbitration Committee. The Wikipedia Signpost, Wikipedia's community-written and community-edited newspaper, reported that a Wikipedia user account used by Merkey was blocked in October 2005 for "Personal attacks, legal threats, harassment, disruption". Merkey was later allowed to come back to edit Wikipedia in May 2007 under a different account. As the result of a ruling by Wikipedia's Arbitration Committe in a July 2007 arbitration case, Merkey and two users who had harassed him on Wikipedia were banned from editing the encyclopedia for one year.

Last week Jimmy Wales faced accusations by former Wikimedia Foundation executive Danny Wool that he misused the non-profit organization's funds, and attempted to expense a visit to a Moscow massage parlor and highpriced bottles of wine. In an interview with CNET TV, Wikimedia Foundation Executive Director Sue

Gardner described Wool as "a disgruntled former employee" and called his claims "a whole bunch of Bill Guerin broke a scoreless tie 28 unsubstantiated rumors and gossip". Wales's former girlfriend, journalist Rachel Marsden, recently they would have for the game. leaked purported instant message transcripts with Wales, which implied Wales had used his influence to change the article about Marsden on Wikipedia. Wales ended his relationship with Marsden and made a public statement to that effect on Wikipedia, and in response some of Wales's clothing on eBay.
