Kenyan government and opposition agree on power sharing

The heads of the government and opposition in Kenya have signed a power sharing agreement aimed at ending the crisis over December's disputed elections. The agreement was reached after a day of talks mediated by former United Nations Secretary-General Kofi Annan and the Chairman of the African Union Jakaya Kikwete.

Kenyan President Mwai Kibaki and opposition leader Raila Odinga signed the agreement before international diplomats and representatives of the Kenyan government and opposition.

Chief mediator Kofi Annan said that the two leaders had agreed on power-sharing agreement that a government structure after five hours of intensive talks.

"I am pleased to be able to tell you country of such enormous and all the citizens of Kenya that the two parties this afternoon completed the work on agenda item three, how to overcome the political crisis," he said.

The two sides agreed to the creation of the posts of prime minister and two deputy prime ministers. The prime minister is accorded authority over the ministries. The prime minister is to be nominated by the largest party or coalition in parliament and can only be removed by a majority vote of the national assembly. The accord also calls for distribution of the ministerial posts according to the relative strength of each party in parliament. And it calls for the changes to be enacted by constitutional amendment, a major that the agreement sticks." demand of the opposition.

Mr. Kibaki and Mr. Odinga pledged to ensure that the accord is implemented and called for unity among all Kenyans. Mr. Annan commended the two parties, saying they reached a common position for the good of the nation. And he had a message for the citizens of Kenya.

"Compromise was necessary for the survival of this country," he said. "Support this agreement, for it is the key to the unity of Kenya. It is the foundation for national reconciliation and it is the springboard for national recovery."

British Prime Minister Gordon Brown released a statement calling government," she said.

"Kenya's leaders have reached a represents a triumph for peace and diplomacy, and a renunciation of the violence that has scarred a potential. Common sense has prevailed, and the Kenyan people have the outcome for which they have hoped and prayed," the statement said

Kenyans are viewing the deal skeptically, such as 56-year old refugee Paul Waweru, "The deal between Raila and Kibaki will help to cool down the situation but I doubt if it will enable us to get back to our homes."

Parliament is to convene next week to enact the measures. Mr. Annan said the negotiations would resume Friday on long-term issues such as constitutional reform and ways to end inequalities in land and wealth distribution.

The two sides have been meeting for nearly five weeks in an effort to find a political solution to the Kenya crisis. One thousand people were killed and several hundred thousand were displaced in the violence that erupted after Mr. Kibaki was declared the winner of a presidential election that the opposition says was rigged.

Rights groups: Forcing Wikileaks.org offline raises 'serious First Amendment concerns'

The American Civil Liberties Union (ACLU) and the Electronic Frontier Foundation (EFF) have sided with Wikileaks.org and will defend them against a lawsuit which took the site off line in the United States. Wikileaks is a website dedicated to hosting leaked documents that are "anonymous, untraceable, uncensorable."

On February 18, 2008, a permanent court injunction issued in the California Northern District Court in San Francisco by judge Jeffrey White, California to Bank Julius Baer (BJB), a Swiss Bank took the domain name offline. However the site remained online via its IP address and alternative domain names. Wikileaks previously published hundreds of documents obtained from a whistleblower of the Swiss Bank, "purportedly showing offshore tax extremely wealthy and in some cases, politically sensitive, clients from the US, Europe, China and Peru."

"Blocking access to the entire site in response to a few documents posted there completely disregards been forced by his airline to the public's right to know," said Ann Brick a lawyer for the ACLU. At least 18 other organizations have signed documents in defense of Wikileaks. Those documents have been forged into a 'joint Amici Curiae ("friends of the Court") brief; which will be submitted to the court and used as Garuda sent the pilot, Marwoto defense evidence in a hearing scheduled for Friday February 29.

Despite the attempts by the ACLU and others, Bank Julius Baer says that their lawsuit has nothing to do with police officials forwarding to with the rights of free speech.

"This action has been brought solely to prevent the unlawful dissemination of stolen bank records and personal account information of its customers. Many of those documents have also been altered and forged," said the Bank.

Recently the Bank has made allegations that they have been "unable to negotiate with Wikileaks" at all before or during legal proceedings. Wikileaks, in a press release denies the allegations.

"Wikileaks at all times responded with grace and dignity to BJBs highly irregular demands and left communication open," said Wikileaks which also adds that the corespondents with the Bank are available on their website on servers in Denmark. "BJB did not submit the correspondence to the court, although it must be absolutely central to the issues held there. We wonder why?"

Garuda Indonesia Flight 200 pilot forced to resign

The pilot of the Boeing 737 that crashed on March 7 upon landing

at Yogyakarta Airport after a domestic Indonesian flight has resign. The crash of Garuda Indonesia Flight 200 killed twentyone people, most being Indonesian innocence, stating that the nationals and five being Australians following a visit by then Australian Foreign Minister Alexander Downer.

The Association of British Insurers has said in a statement that the cost for the earthquake is "likely to run into the low tens of millions of pounds."

The Senior claims manager at the UK bank Norwich Union has described the damage by saying that at the moment most insurance claims regarding the earthquake describe "minor damage such as tiles off roofs, breakages inside the homes and brick walls collapsing." It has also been reported that approximately 1,200 insurance claims were made in the first twelve hours after the earthquake hit Britain.

These reports come one day after the United Kingdom was hit by a 5.2 earthquake. Tremors were reported as wide spread as Edinburgh, Manchester, Sheffield, Middlesbrough, Cambridge, London, Birmingham and Southampton .

Tim Connelly and Ales Kotalik each scored for Buffalo in the third period, giving the Sabres their first breaks a 4 game losing streak. The win in three games. Minnesota Wild @ Tampa Bay Lightning After a scoreless first period, Todd

Fedoruk put the Wild up by 1 early in the second period with a short handed goal. That was closely followed by Pavol Demitra's 13th goal of the season. Michel Ouellet put the Lightning on the scoreboard 12:22 into the second period. Brian Rolston scored his 22nd goal of the season on a Minnesota power play to put Minnesota up by 2 in the third period. Jeff Halpern would put the Lightning within 1 goal, but despite a late third period power play, plus the extra skater on for the pulled goaltender, they couldn't tie the score. Minnesota Lightning have now lost 5 straight. Niklas Backstrom made 31 saves for Minnesota, earning his 25th win of the season.

Toronto Maple Leafs @ Florida **Panthers**

Jassen Cullimore scored first for the Panthers at 9:27 in the first period. Brett McLean would give Florida a 2 goal lead going into the first intermission. Jeremy Williams, who had a goal in each of his other two NHL appearances, scored his first goal of this season 6:56 into the second period to put Toronto within one goal. In the third period, Toronto captain Mats Sundin scored to tie the game at 2-2. Rostislav Olesz would retake the lead for Florida 11:45 into the third, but Sundin scored his second of the night with 1:08 left in regulation to send the game to a shootout. Tomas Kaberle scored the only shootout goal, when his wrist shot beat Tomas Vokoun through the five-hole. Vesa Toskala made 37 saves for the Leafs.

Phoenix Coyotes @ Chicago Blackhawks Chicago's Jason Williams scored the only goal of the game, a shot that deflected off of Coyotes center Joel Perrault's skate, 7:58 into the first period. Patrick Lalime stopped all of Phoenix's 32 shots, earning his first shutout since February 7, 2007. Ilya Bryzgalov only allowed 1 of Chicago's 24 shots, but the one allowed turned out to be the game winner.

Colorado Avalanche @ Vancouver Canucks

Mason Raymond put Vancouver on the board after a scoreless 1st period. Later in the second period, Andrew Brunette scored his 13th goal of the season to tie the score 1-1. In the third period, Alex Burrows scored on a goal with 1:45 left in regulation, a goal that was allowed after a video review was done to verify that the puck completely crossed the goal line. Joe Sakic tied the score with 15 seconds left to send the game into a shootout. Sakic and Marek Svatos each scored on the shootout, giving Colorado their second consecutive win. Jose Theodore stopped 29 of Vancouver's 31 shots. Roberto Luongo stopped 24 of Colorado's 26 shots.
