

Tropical storm Humberto eyes Gulf Coast

The eighth named storm of the Atlantic Hurricane Season, tropical storm Humberto, was named today over the Gulf of Mexico.

The tropical storm was about 70 miles south-southwest of Galveston, Texas at 2 p.m. EST and was moving towards the north at 6 mph.

Maximum sustained winds associated with the storm stood at 45 mph.

But, forecasters warn that additional strengthening is possible before the storm makes landfall.

While heavy rain is already pounding the Gulf Coast, Humberto's center is not expected to reach the coast of Texas until late tonight.

The National Hurricane Center (NHC) issued a tropical storm warning from Port O'Connor, Texas, to Cameron, Louisiana.

Anywhere from 5 to 10 inches of

rain is expected along the upper and middle coast of Texas, as well as in southwestern Louisiana. Some areas to be impacted by the storm may see rain totals near 15 inches, according to the NHC.

Also, the NHC warned storm surge flooding of 2 to 3 feet is possible.

2007 Rugby World Cup: Tonga, Fiji and Italy win

In the 2007 Rugby World Cup, Tonga started their campaign with a 15-25 win over the United States. Fiji won their opening match by four points in a close contest against Japan.

Romania, playing their first match of the tournament, led Italy just after half time but eventually fell to a 24-18 defeat.

In Pool A, Tonga raced to an early lead after Finau Maka scored a try in the second minute and Pierre Hola added the conversion. However the United States pinned them back for most of the first half Fiji are third in the pool with five with Pierre Hola scoring just two penalties for Tonga, giving them a 13-0 lead. Shortly before half time Mike Hercus scored a penalty for the United States to take the score to 13-3 at the interval.

The Americans controlled the game for much of the second half. Mike MacDonald scored a try for the Americans to pull the score back to 13-8, but Tonga hit back with a try from Joseph Vaka. Louis Stanfill scored a try to close the gap to three points, but Viliami Vaki scored with ten minutes remaining to claim the victory for Tonga.

defeats.

Fiji overcame Japan in a dramatic encounter in Pool B. Nicky Little kicked Fiji to an early lead, but Shotaro Onishi scored two penalties to give Japan a 6-3 lead in the 30th minute. Fiji went ahead The second landing gear failure on with a try from Akapusi Qera, and Japan's Onishi scored a penalty just before half time reducing Fiji's lead to one point.

Onishi scored another penalty after the restart and Japan led once more. Qera scored his second try for Fiji in the 49th minute, but Luke Thompson scored a try for Japan two minutes later. A try from Seru Rabeni once again gave Fiji the advantage, but Japan were kept in the match by a Tomokazu Soma try. Fiji stretched their lead to 11 points after Kele Leawere scored a try, and a last minute Luke Thompson try was not enough to snatch the win for Japan.

Scandanavian Airlines System landing gear failures prompt grounding of Bombardier 0400s

a Scandanavian Airlines System (SAS) de Havilland Canada Dash 8 (also known as a Bombardier Q400 following Bombardier's purchase of de Havilland Canada from Boeing) within the space of a week has prompted the grounding of many of the twin-engined turboprops.

On, Scandinavian Airlines Flight 1209 suffered a right landing gear failure during landing at Aalborg Airport, Denmark. A fire broke out during the crash, and five people sustained injuries. This was followed today by the similar crash of Scandinavian Airlines Flight 2748 at Palanga Airport, Lithuania. No-one was injured.

The accidents have resulted in Bombardier recommending the grounding of all Q400s, which have undertaken more than 60,000 flights, as a "precautionary measure". This affects leading carriers around the world, Japan Airlines, Austrian Airlines Group and Augsburg Airways, and covers around 60 aircraft.

SAS and Horizon Air have grounded 27 and 15 aircraft respectively, while Flybe have grounded six. Another airline, Porter Airlines, which operates the type exclusively against any others, have pointed out that their enough flights to be affected by the measures.

The landing gear are manufactered in the United States by Goodrich

Former Philippine President Joseph Estrada found guilty of plunder

Former Philippine President Joseph "Erap" Ejercito Estrada was found guilty by the Sandiganbayan (antigraft court) for plunder but found him not guilty on a count of perjury.

The Philippines' 13th President was arrested in April 2001 after being ousted in a peaceful revolution in January of the same year for allegedly amassing US\$ 85 million (PhP 46=US\$) from kickbacks and for failure to declare his true assets and liabilities as a requisite for any public elected or appointed official.

After almost six years of trial, Estrada faces a lifetime of imprisonment or at least 40 years in prison.

The former president's son, Senator Jose "Jinggoy" Estrada and personal lawyer Edward S. Serapio who also faced similar charges of plunder and perjury

court was created to specifically hear the case of Estrada and found beyond reasonable doubt that the former President was guilty of plunder.

The court's decision stated that Estrada received money from illegal gambling and collected commissions from the sale of publicly listed Belle Corp. shares.

The court stated that it found not enough evidence to tie Estrada to charges of misappropriating tobacco excise taxes and amassing wealth deposited in the so-called "Jose Velarde" account.

The 262-page decision stated that, "The predicate acts alleged [in the two cases] were linked by the fact that they were plainly geared towards a common goal which was justice, whitewash or cover-ups." the accumulation of ill-gotten wealth ... and that they shared a pattern or a common method of commission which was the abuse or misuse of the high authority or power of the presidency."

As a result of the court's decision, the state will forfeit Mr. Estrada's accounts that includes P545.29 million (US\$11.5 million) credited to the Erap Muslim Youth Foundation and the P189-million (US\$ 4.10 million) Velarde account, including the so-called Boracay Mansion in New Manila, Quezon City.

Estrada, who was also a popular movie actor said in an interview after the verdict that the three person panel of judges of the antigraft court were "pressured" to ensure the legitimacy of the incumbent administration of President Gloria Macapagal-Arroyo. highest level of alert, more than a

Mrs. Arroyo assumed the office of the President on June 20, 2001 when a peaceful uprising forced Mr. Estrada to step down from office.

The 70 year old former President declared this Sunday that his lawyers will appeal should the court find him guilty and he is prepared to face incarceration. Estrada added that he will not ask for any form of pardon from incumbent President Gloria Macapagal-Arroyo who assumed office when Estrada was ousted.

Mr. Estrada proclaimed before members of media after the verdict was read saying, "I submitted myself to the rule of law when I allowed the impeachment proceedings against me to take its course. I did not resort to influence, the trial nor to any acts that may constitute obstruction of

The former president reemphasized his position that he will never ask for any form of pardon from Mrs. Arroyo's administration and he was prepared to serve his sentence at the National Penitentiary among the common people with no special privileges.

Estrada, has been on detention by virtue of a "house arrest" at his rest house at Tanay in Rizal Province, east of the capital Manila.

"I am at peace with myself notwithstanding the guilty verdict because you, my beloved countrymen, have overwhelmingly acquitted me," Estrada added.

The Philippine government placed the entire military and police on its week ahead in preparation for the

Estrada verdict.

Traffic around the anti-graft court was re-routed and classes from among nearby schools were also suspended to pre-empt any possible security problems resulting from pro-Estrada supporters.

Japanese Prime Minister Shinzo Abe resigns

Reports are stating that Japan's Prime Minister Shinzo Abe is to

"Unfortunately, he will announce has made a very significant decision," said Liberal Democratic Party (LDP) chairman for the affair of parliament, Tadamori Oshima.

At 2:00 pm (local time) NHK broadcast the press conference where Abe announced his coming resignation. Abe would have been Japan's Prime Minister for just under one year. He was elected on September 26, 2006.

At the conference, Abe admitted he lacked trust from Japanese people and Ichiro Ozawa, the leader of the opposite party had refused a meeting Abe had offered today. Abe expressed his concerns to continue the current foreign military mission, reportedly speaking about Afghanistan, and his expectation that resigning that issue and would allow the government to continue the

Not mentioned at the conference, Abe's cabinet faced domestic problems too. Due to the financial scandal, Takehiko Endo resigned from the post of Minister of Agriculture on September 3, just 8 days after he was appointed to the post, the Japan Times reported.

According to Ozawa, he had reported Abe would have liked to come to "greet" and had replied the question time at the Diet would be enough.

Massive earthquake strikes **Indonesia on September 12**

According to the United States Geological Survey (USGS), a massive earthquake with a magnitude of 8.4 has struck Indonesia and a tsunami is reported to have been generated. Some smaller aftershocks with magnitudes between 5.2 and 5.7 were also reported in the region. At least 4 have been killed and dozens injured.

The National Oceanic and Atmospheric Administration has issued a tsunami warning saying that the guake had the potential to "generate a widespread destructive tsunami that can affect coastlines across the entire Indian Ocean."

"Sea level readings indicate a tsunami was generated. It may have been destructive along some coasts. Based on these data, the threat continues for all coastal areas of the Indian Ocean," said the NOAA tsunami warning.

The earthquake was recorded at 6:10 p.m. (local time), 130 kilometers (80 miles) southwest of MOEA of R.O.C. Fraser Watts scored 46, but Shahid Afridi dismissed Gavin Hamilton and Neil McCallum in the same over to reduce Scotland to 54-4. Scotland were bowled out in the final over for 120 runs. Umar Gul took two wickets in two balls and finished 4-19.

Tunisian swimmer Oussama Mellouli stripped of championship for doping

On 11 September 2007, Tunisian star swimmer Oussama Mellouli was stripped by the Court of Arbitration for Sport in Lausanne, Switzerland, of his world championship and another world championships silver medal from the 2007 World Aquatics Championship, which were held in Melbourne, Australia, in March.

He was also suspended for 18 months retroactive to 30 November 2006 – all for testing positive for amphetamine, after using the drug Adderall, which aids concentration levels, and which is widely used by college students when cramming for exams.

A few weeks after the conclusion of the 2007 World Aquatics Championships in Melbourne in late March 2007, reports began to surface that Mellouli had tested positive for a banned substance at the US Open in November 2006. These reports surfaced because FINA, the international governing body of the sport, had discovered that Tunisian authorities had

known about the positive test and only given him a warning. The rules state that when an athlete tests positive for a banned substance, he or she must be given a 2 year ban from the sport. Therefore, FINA had taken the case to the Court of Arbitration for Sport. Finally, after months of speculation, yesterday Oussama Mellouli lost his case before that Court.

He escaped the worst possible punishment, because the timing and the retroactive status of the suspension give Mellouli a chance to compete in the 2008 Summer Olympics in Beijing, where he is a favorite in several medium distance races.

However, he loses the distinction of having become the first Arab world champion in the history of competitive swimming (in 800 m freestyle), and loses another silver medal (in 400 m freestyle) from his best-ever showing at the Australian world championships.

2007 Twenty20 World **Championship: Kenya vs New** Zealand

New Zealand defeated Kenya by nine wickets in Group C of the 2007 Twenty20 World Championship at Kingsmead, Durban, South Africa.

Russian President Vladimir Putin dissolves government

According to the Kremlin, Vladimir Putin, the President of Russia, has "dissolved the country's aovernment."

Prime Minister of Russia Mikhail Fradkov has resigned, citing his reason as being "the approaching major political events in the country and a desire to give the president full freedom in making decisions, including personnel." Putin has nominated Victor Zubkov to replace him, and a new cabinet is expected to follow as well.

Parliamentary elections are to still expected to take place in three months as the parliament has not been dissolved, and presidential elections will take place in six months.

US says Israel hit Syrian targets in airstrike last week

Officials with the United States Department of Defense have stated that Israeli fighter planes struck at least one target inside Syria a week ago. On September 7, Syrian fighter planes fired upon Israeli jets that were allegedly "dropping ammunition" in the

The actual target, or the extent of the damage has yet to be determined, but U.S. officials say a weapons storage facility was the likely target. The Israeli government believes that Iran is sending weapons through Syria to Lebanon to arm the militant group Hezbollah. Israel also thinks that those weapons are coming from North Korea.

"It wasn't big. It was a quick strike. They were engaged by the Syrians, they dropped their ordenance and scooted out of there. The Israelis think North Korea is selling to Iran and Syria what little they have left," said an unnamed Defense Department official who also said that Israeli planes are taking photographs of possible targets and nuclear power facilities inside Syria.

Syrian officials believe that the ammunition was dropped in order to make the Israeli planes go faster so that they may escape.

"They were fleeing and in order to speed up the planes they dropped the munitions. Israel is seeking military escalation. We are exerting efforts so that we don't fall into this trap," said Bashar Jaafari, Syria's Ambassador to the United Nations.

Israel has not confirmed or denied the reports, simply stating "we cannot discuss military operations."

Free-to-air channel sues pay TV operator over rugby screening

The owner of TV3 and music channel, C4, has made an unprecedented move by winning an interim injunction against New Zealand's monopolistic pay television operator, Sky Network Television over their amount of

content screened of the Rugby World Cup. TV3, the official RWC television broadcaster for New Zealand, described Sky's actions as illegal and unethical.

MediaWorks, which runs TVWorks and RadioWorks, filed the injunction against Sky in Auckland's High Court today saying it breached fair dealing practices over its use of Rugby World Cup footage. Sky is now temporarily banned from screening TV3's WRC footage on The Cup, Rugby Highlights (channel) and Sport 365 Highlights.

An agreement between MediaWorks and other broadcasters, including Sky, was signed allowing content to be used for news purposes, but state Sky breached the agreement and used content of which it had no right to.

Bill Ralston, former head of news and current affairs at TVNZ (Television New Zealand), said when they had 2003 Rugby World Cup rights, "TV3 pushed the boundary by taking a bit more than they should." The three networks usually pushed the rules but the boundaries were relaxed. "Simply because Sky controls so many sports rights themselves, you can normally get a good quid pro quo out of them. You relax a bit, they relax a bit."

The TVWorks Chief Operating Officer said, "We are simply acting to protect our interests, and the interests of the viewing public." Rick Friesen said, "We believe Sky's behaviour to be unethical and illegal, and we will be taking whatever action we can to protect the interests of ourselves and every Rugby fan in New Zealand."

An undisclosed amount of money was paid to secure the rights to

screen footage, beating TVNZ and Sky. It has been rumoured the cost is to be in the millions of dollars (NZ\$).

Sky is yet to make a comment on this action.

US President George Bush to reduce amount of troops in Iraq

According to United States officials at the White House, President George W. Bush will be cutting the amount of U.S. troops in Iraq by as much of 30,000, to "pre-surge" force levels, and the withdraw could take place as early as next Summer, but with certain "conditions" applying.

The plans are expected to be formally announced in a speech Bush is expected to make on Thursday at 9:00 p.m. (eastern time).

Officials say that the President will endorse the reduction of troops recommended by General David Petraeus.

"I believe that we will be able to reduce our forces to the pre-surge level ... by next summer without jeopardizing the security gains we have fought so hard to achieve. The level of security incidents has declined in eight of the past 12 weeks, with the level of incidents in the past two weeks the lowest since June of 2006," said Petraeus while testifying in front of the U.S. Congress on Monday.

According to officials, the conditions on the reduction of troops depends on whether or not violence in Iraq continues to decline, and how much political stability and security progresses. Currently, there are 168,000 U.S. troops serving in Iraq, the most that have ever been in the country.

The Canadian Idol Top 10 started off the show last night singing Jon Bon Jovi's "You Give Love a Bad Name".

The top 10, and a duet with the top two, did several performances throughout the show.

Canadian-International pop-rock singer Avril Lavigne performed "Hot" and "When You're Gone" from her third new album the "Best Damn Thing".

Season four winner of Canadian Idol, Eva Avila performed her song "Fallin' For You". Melo and Bixby presented her with gold and platinum disk awards for her debut single "Meant To Fly" and her debut album "Somewhere Else".

Country-rock singer Jon Bon Jovi, who mentored the singers for Monday's performances, sang their new song "Lost Highway" and 2000 song "It's My Life".

Canadian Idol allowed auditioners, their top 22, and top 10 to perform with instruments this year. No other Idol shows have allowed this. Top ten competitors Greg Neufeld sang and performed with his guitar and Dwight d'Eon sang and performed with his electrical guitar, with the top 10 last night.

Canadian Idol's official top 3 competitors, including top three's eliminated Carly Rae Jepson from Mission, British Columbia, are set to have an "Idol Winner's" tour across 15 Canadian cities this fall. The tour will start November 18, 2007 in Charlottetown, Prince Edward Island. They are expected to tour cities in Nova Scotia, New Brunswick, Newfoundland, Ontario, Manitoba, Alberta, Saskatchewan and British Columbia. It finishes with a final show in Edmonton, Alberta on December 12, 2007.

It's the first tour the show has ever done.

Melo, the winner, was a construction worker in Hamilton. He auditioned at the nearby Toronto auditions.

At the beginning of the season Bixby and Melo appeared as stiff performers but changed drastically throughout the weeks. Melo was in the bottom three, three times.

An estimated five million votes were cast following Monday's performances.

Opposition leader takes early lead in Sierra Leone presidential run-off elections

The results of Saturday's presidential run-off elections in Sierra Leone are being tallied, and early data indicated that opposition leader Ernest Bai Koroma of All People's Congress

(APC) was out front with 64 percent support. Vice President Leone People's Party (SLPP) had garnered 36 percent support, according to the country's election commission.

However, only 18 percent of the polls had been tallied so far and the election commission pointed out that the early poll results came mainly from an area in western Sierra Leone having strong support for APC. It could take up to 12 days to count all the votes. For the results that have been tabulated, voter turnout has been determined to be approximately 73 percent.

The lead-up to the run-off election had been marred by reports of violence and, on election day, monitors had observed some irregularities such as ballot box registrations. However, most observers, both domestic and international, agreed that the elections were carried out in an orderly fashion.

On September 2, the two presidential candidates signed a communiqué, which outlined ten "matters of concern" to be dealt with "immediately". The agreement laid out a framework for cooperation on issues such as security and a weapons ban. There actions of intimidation, harassment and use of provocative language, physical violence directed at any person/persons or the malicious destruction of property for any reason."

One group of election monitors from the U.S.-based National Democratic Institute for International Affairs (NDIIA) expressed their satisfaction with the election process. "Despite

heightened tension and several reported instances of electionrelated violence during the campaign period, the delegation considers that the overall electoral process was generally transparent and peaceful," said NDIIA in a statement on September 10.

The September 8 run-off elections followed the first round of presidential and parliamentary elections held on August 11, which were the second held since 2002 after the end of the civil war. Opposition leader Koroma, 54, garnered 44 percent of the vote, while Berewa, 69, won 38 percent support. Should Koroma win ultimately, it would mark the APC's return to power for the first time since it was overthrown in a 1992 coup.

In a statement following Saturday's run-off elections, the spokesperson for the UN Secretary-General Ban Ki-moon expressed Mr. Ban's support for the process. "The Secretary-General is pleased to note that the second round of the presidential election in Sierra Leone took place on September 8 in a generally orderly and peaceful atmosphere, in spite of the tensions and violence that marred the campaign period. The Secretary-General urges the political parties and people of Sierra Leone to exercise restraint as counting of the ballots proceeds and to resolve all arising disputes through the existing legal channels."

Spokesman for the U.S. Department of State Sean McCormack relayed the sentiment of the administration. "The United States congratulates the Republic of Sierra Leone for the peaceful presidential run-off electoral process on September 8, 2007. We commend the independent

National Electoral Commission, the Sierra Leone Police, and especially the people of Sierra Leone for the overall calm and sense of order shown as voters cast their ballots."
