STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS

BE IT KNOWN That on this Fifth day of October in the year of our Lord, One thousand nine hundred and eight...

ARTICLE I. The name of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY...
