MOSCOW.—DANIELSON AND OVERBECK.—The Pacific News states that fire engines attached to the U.S. schoner Ewing, seized Lieut. Gibbons, the officer in command, and threw him overboard, and then made their escape in the boat. He was recovered, though severely injured, and was brought to San Francisco.

The Ewing generally was healthy, and the incident was considered a mere accident.

Wm. G. Jensen, Esq., of San Francisco, passenger in the Empire City, says he has been greatly crowded, and we make the following extracts, there being but little additional news of an exciting character.
