SUBJECT: Update Recommendation to Release or Transfer to the Control of Another Country for Continued Detention (TR) for Guantanamo Detainee, ISN: US9AF-000561DP (S)

1. (FOUO) Personal Information:

- First name Middle names Last name: Abdul Rahim Mannan
- Aliases: Abdul Rahim Muslimdost and Rahim Muslim Dost
- Place of Birth: Jalalabad, Afghanistan (AF)
- Date of Birth: 1 January 1960
- Citizenship: Afghanistan (AF)

2. (FOUO) Health:

- a. History: 44 year old Afghan with history of diabetes and multi-nodular goiter (enlarged thyroid gland). Detainee required surgery on thyroid gland on 6/8/2004 and has currently been discharged to his cell. He had prior surgery on his thyroid gland in 1992 and also has history of chronic back pain, latent tuberculosis and anemia.
- b. Treatment: Glucophage (for diabetes), has follow up scheduled for July 2nd
- c. Function: Detainee has no functional impairments
- d. Prognosis: Excellent, requires primary care visits every 4-6 months

3. (S) Detainee Summary:

- a. (S) Detention Information: Same as stated in JTF CG memo, dated 25 November 2003.
- b. (S) Prior Assessment: On 14 April 2004, MG Mitchell R. LeClaire, Deputy Commander JTF Guantanamo, recommended that detainee be released or transferred for to the control of another country for continued detention.

c. (S) **Intelligence Value:** JTF GTMO has determined that this detainee has been fully exploited.

4. (S) Detainee's Conduct: Detainee's has some history of non-compliance. These incidents have consisted mostly of refusal of meals or cross block talking.


5. (S) EC Status: Detainee's enemy combatant status was reassessed on 24 February 2004, and he remains an enemy combatant.

6. (S) JTF GTMO New Assessment:

a. (S) **Summary:** JT GTMO has determined that the detainee poses a low risk, due to his medical condition.

b. (S) **Recommendation:** Based on the detainee's health status, intelligence value and risk level, JTF GTMO recommends this detainee be released or transferred to the control of another country for continued detention.

7. (S) Coordination: JTF Guantanamo notified the Criminal Investigative Task Force of this recommendation on 2 March 2004. JTF GMTMO and CITF agree on the threat of this detainee.
