Le "Conformateur Peyry" est un système d'une grande précision appliqué à la coupe des vêtements, avec ou sans coutures. Il fonctionne de deux manières: s'ajuste aux mesures prises sur la personne et se conforme à toutes les courbes et lignes du corps; s'ajuste aussi en se plaçant sur la personne même et prend les contours du corps horizontalement et verticalement. Breveté en 1892, et médaillé à l'Exposition Universelle de Paris en 1900, il est donc universellement recommandé. Le système est expliqué par un livre illustré renfermant tous différents diagrammes et dessins. Les dames et les messieurs pourront à première vue en comprendre les secrets, et quelques explications et un peu de pratique les rendront maîtres de cet art de la coupe. Des diplômes seront donnés aux élèves qui suivront un cours complet.
