on August 15<sup>th</sup> 1903, Ida Lirpola born at Brooklyn on September 13<sup>th</sup> 1905, and Carmine  
Lirpola born at Brooklyn on October 13<sup>th</sup> 1907

In support of the above application, I do solemnly swear that I was born at Bagnoli Irpino  
Italy (Province of Avellino) in on or about the 3<sup>rd</sup>  
day of July 1877; that I emigrated to the United States, sailing on board  
the S. Chandernagor from Naples (Italy) on or about the 15<sup>th</sup> day  
of May 1892; that I resided 16 years, uninterruptedly, in the United States,  
from then to now at New York and Brooklyn; that I was naturalized as a  
citizen of the United States before the County Court of the County of Kings  
at the Barogh of Brooklyn N.Y. on the 28<sup>th</sup> day of July 1898, as  
shown by the accompanying Certificate of Naturalization; that I am the IDENTICAL PERSON described  
in said Certificate; that I am domiciled in the United States, my permanent residence being at  
251 Graham Ave, Brooklyn, in the State of New York  
where I follow the occupation of barber; that I am about to go abroad  
temporarily; and that I intend to return to the United States within two or three  
months, with the purpose of residing and performing the duties of citizenship therein.
