PUBLIC SCHOOLS. THE Regents of the Central and Primary schools having procured a healthy, commodious, and central position for the upper primary school...

Convent of Ursines. In the Primary Schools are taught Reading, Writing, Arithmetic, Geography, and the rudiments of Grammar in the English and French languages.

In the Central School are taught the English, the French, Spanish, Latin and Greek languages; Mathematics; Literature; History; Natural Philosophy; &c.

There is also, attached to the establishment a drawing school under the direction of M. Bigot.

Terms of Admission. In the primary schools:—For tuition in both languages, two dollars per month. In the Central school; for tuition in any or all of the branches taught in the school and which the pupils is capable of pursuing, three dollars per month.

Books and Stationary furnished by the pupils or charged separately. In each of the schools one hundred pupils unable to pay for their education are admitted and taught gratis.
