William J. 'Bill' Elfering (born August 18,1941) is an American politician in Umatilla County, State of Oregon, USA. He is an elected County Commissioner in Umatilla County. He resides in Hermiston, Oregon with his wife, Yvonne.

Early Life

Elfering was born in Long Beach, California to John C. and Goldia (Branstetter). He lived with his parents in Torrance, California for the first two and a half years of his life at which point his family moved to Vale, Oregon. He was raised there on the family farm. His father was a three term county sheriff and his mother was very active in community affairs.

Educational Background

He attended school in Vale, Oregon. He played on three of the Vale state championship football teams in his four years at Vale High School. Upon graduation, he attended College of Idaho in Caldwell, Idaho for a year before transferring to University of Portland in Portland, Oregon. He graduated Cum Laude with a Bachelor of Arts degree in history and a minor degree in Spanish language.

Family

He married the former Yvonne Smith (August 31, 1963) in Pendleton, Oregon. They are parents of five children: Kori Kountz, John Elfering, Patti Voelker, Mark Elfering and Mary Groesbeck

Business Career

During college, he worked part-time at Foster Sporting Goods to pay for his education. His senior college year, he worked full time managing the sporting goods store on N Lombard Street in Portland at the same time attending college full time and achieving a 4.0 GPA. In 1964, Elfering began his career with State Farm Insurance Company in Salem, Oregon, as an auto underwriter in the Idaho/Montana division. He began as an agent in 1965 building a State Farm agency in Vale, his hometown. Two years later, he was back in Salem as an assistant superintendent of the Agency Department. With a strong desire to return to Eastern Oregon, he and his family moved to Pendleton in 1970 acquiring an agency in Pilot Rock.
