From Colombia.—Capt. Ferguson, arrived at Philadelphia from Laguira, informs the Editors of the Gazette that Col. Cavajah, the man who shot Col. Ferguson, had given himself up at Bogota, and had informed of a number that they had been several arrested at Caracas, supposed to have been connected in the conspiracy. There was a report in Caracas that Cisneros, the famous Robber, had died from the wounds he had received in his last attack.

The annexed interesting article is translated from the "Phare du Havre" of the 28th October:

**United States and England.**—The London Times of the 30th Oct., notices the publication by Parliament of a series of documents and official papers and letters, concerning the Tariff laws of the United States, which it speaks of as likely to afford materials for future comment. The Times closes its article with the following:
