BACKGROUND OF SSOG

Spastic Society of Gurgaon (briefly known as SSOG hereinafter), was founded in 2008 by some eminent doctors drawn from the super specialty fields of pediatrics, pediatric surgery, neurology, neuro surgery, orthopedics, replacement surgery, physiotherapy, psychology, psychiatry, ophthalmology, dentistry, ayurvedic medicine with support from legal advisors, special educators, and social workers. It is dedicated to the cause of welfare of the spastic children in Haryana with intensive thrust on Gurgaon and the NCR of Delhi. The whole team at SSOG is not only dedicated but is also eager to usher in a transformation in the mindset of the general masses by changing their attitude towards the differently abled children.

SSOG is arranging many facilities for such children. These facilities include identifying such children in the District and then reaching out to them by coordinating supply of all medical facilities, wheelchairs, orthotic devices, standers, walkers, braces, necessary vaccinations, medical check-ups etc. as needed from case to case to enable these children lead better and meaningful lives. As our team (consisting mainly of doctors with super specializations in their respective fields), gets flooded, during course of their medical practice in Gurgaon, with such CP children, who are leading life of not only extreme pain and isolation but also that of extreme penury and neglect.

Services being rendered by SSOG through two separate delivery channels are

- Centre for Special Children (CSC) and
- Centre for Physiotherapy for Senior Ciitizens (CPSS)

The centers were inaugurated by Sh. Rajender Kumar Kataria, Deputy Commissioner, Gurgaon.. Smt. Asha Hooda wife of Honorable Chief Ministaer of Haryana, Sh. Bhupinder Siongh Hooda also visited the Centers to shower her blessings.

VISION

To help people with developmental disabilities by providing them with quality rehabilitation services to enable them to lead their lives with dignity.

MISSION

Our mission is to protect the rights of the persons with developmental disabilities and to uphold their honor and dignity by making them self reliant.

OBJECTIVES

- 1. To achieve continuous improvement in services.
- 2. To improve competence of our staff on regular ongoing basis by imparting them with specialized trainings.
- 3. To regularly train parents and care givers to enable them to take better care of the persons with developmental disabilities.
- 4. To make lives of these persons more meaningful by making them more self reliant.

CENTRE FOR SPECIAL CHILDREN (CSC)

This **Centre for Special Children** is equipped with toys, therapeutic toys, equipments and large space provides the following services to persons with disabilities of autism, cerebral palsy, mental retardation and multiple disabilities:

- 1. Specialized occupational therapy,
- 2. Development therapy,
- 3. Special education,
- 4. Counseling
- 5. Medical OPD on every Saturday
- 6. Physiotherapy
- 7. Vocational Training for self employment
- 8. Training for employment
- 9. Medical support
- 10. Arrangement for special equipments viz. wheel chairs, orthotics, CP stands and CP chairs etc.
- 11. Special assisting services to persons with disabilities of autism, cerebral palsy, mental retardation and multiple disabilities.

(All the services provided at CSC are free of cost.)
Timings: Morning 9 to 12, Evening: 5 to 7(summers) 4 to 6 (winters)

CENTRE FOR PHYSIOTHERAPY FOR SENIOR CITIZENS (CPSC)

This Centre for Physiotherapy for Senior Citizens is providing:

- 1. Shortwave Diathermy (SWD)
- 2. Physio consultation
- 3. Sports medicine consultation
- 4. Rehabilitation consultation
- 5. Development physiotherapy
- 6. Neuro physiotherapy
- 7. Tens therapy
- 8. IFT therapy
- 9. Ultra sonic therapy
- 10. Paraffin wax therapy
- 11. Exercise therapy
- 12. Manual exercises

(Rates as prescribed and approved by Haryana Government are charged per modality/per session)

These exercises are recommended for treatment of low back ache, cervical sponydilitis, ostoathritis, frozen shoulder, rheumatoid arthritis, lumbago, hip replacement, paralysis,

lumber spondylosis, pelvic inflammation, joint pains, sprains and injuries, knee replacement, post fracture stiffness, sciatica, slip disc, general weakness.

Timings: Morning 9 to 12, Evening 5 to 7(summers) 4 to 6 (winters). Monday to Saturday

SPREADING GOOD HEALTH

1. THROUGH MEDICAL CAMPS SPECIAL DRIVES

India does not have adequate numbers of qualified general doctors to look after the mental retarded children seeking medical help in the villages. Thus, for such people, access to specialists in pediatrics and orthopedics who offer quality health care free of cost remains an impossible dream. Spastic Society of Gurgaon's strategy for the clinical services at the doorstep is the topmost tier of its service delivery model. Camps are organized at the doorsteps of the disabled children for their medical care based on their regular records. Various camps for the medical check ups and vaccinations for the disabled children are organized at regular intervals.

2. THROUGH NIRAMAYA HEALTH CARDS FOR THE DISABLED

Under 'NIRAMAYA' scheme if National Trust, Ministry of Social Justice and Empowerment, our Society mobilized many applications from Gurgaon district for issue of national biometric Identity Cards to the persons with the said disabilities. Person to person contact with children and their parents have been established by us in the Districts of Gurgaon and Mewat.

3. THROUGH EVENT MANAGEMENT AND SALE OF ITEMS PRODUCED BY THE DISABLED

SSOG promotes self reliance of the children and works for their growth as independent individuals. The children are being trained vocationally and being imparted trainings which is conducive in making them independent to the best possible level. The items manufactured by them are also sold by us at different points of sale. SSOG is always exploring employment opportunities for the disabled persons in the district. Many functions and events are arranged for encouraging their active participation in all such functions.

4. THROUGH SPOT ISSUANCE OF DISABILITY CERTIFICATES

With the help of the local administration and the civil hospital authorities many disability camps are organized at regular frequency for expediting the process of issuance of the disability certificates to the disabled. In some of the camps as many as 255 disability

certificates were issued and delivered to the beneficiaries on the same day. This has enabled the Society to clear the backlog which is created due to delays in issuance of such certificates

SCREENING OF LEGAL GUARDIANSHIPS OF THE DISTRICT

Applications for guardianship received by the LLC Gurgaon are disposed off and certificates are issued after due processing of the applications.

ROLE AS LOCAL LEVEL COMMITTEE MEMBER AT GURGAON

SSOG is appointed as LLC-NGO member for Gurgaon District by National Trust, Ministry of Social Justice and Empowerment. Government of India. The quarterly progress report of the LLC Gurgaon are submitted to the National Trust. The reports highlight the progress made on disability front in the district during the quarter.

TRAINING TO VOLUNTEERS

SSOG is also imparting training to the interested persons / activists and volunteers in occupational therapy, physiotherapy, special education, hospital administration, patient relationship and marketing.

BRINGING WARMTH AND SUNSHINE

It is an occasion of great joy and celebration when a child is born. But in some cases after few months of the birth, the family discovers that the child is not able to hold objects, crawl or walk. A spine chilling news is broken to the parents that the child has an incurable and irreversible condition called 'Cerebral Palsy' and may never be able to hold neck, walk or talk like a normal child next door. A sense of gloom dawns for a few days, at times, it lingers on for many years before the parents get adjusted to the thought of being mother and father of a spastic child. But, then, life is as such. One is to reconcile with the situation and move ahead. 6. Neuro physiotherapy

On the positive side, in the journey of life, parents are blessed with a new companion who is to be taken care of. In case of cerebral palsy, the parents are to be prepared for long term care of the child. But, one feeling which one is unable to overcome as a parent to a spastic child is that what will happen to the child after death of the mother, the father or the caregiver, towards whom the child was always anxiously looking for, for all his daily care and emotional needs. This thought prompted us to take certain initiatives for short term and long term care of these children. We request the reader to wait here for a moment and introspect. Whether this city of Gurgaon and NCR, which is overflowing with wealth and opulence, ever thought of such children who depend upon others for all their daily, emotional and future needs? Let us touch another point. Have you ever met a spastic child and interacted with him for a few moments. Do interact with a spastic child today. You may be taken aback. They are intelligent brains at work in

visibly deformed bodies. They are, by and large, jovial persons despite the fact that they live with severe multiple disabilities. Spastic Society of Gurgaon aims to address certain questions related to welfare of spastic children of Gurgaon, NCR and Haryana. People from various walks of life have joined hands to make efforts to arrange for long term care of such children; and also to help their parents live life fully, purposefully and contentedly by bringing them closer to each other, by creating coordination between various agencies, social workers, professionals and infra-structure providers. Efforts are also being initiated to make environment of Gurgaon, the millennium city of India, more spastic friendly.
