CHARTER

STATE OF LOUISIANA PARISH OF ORLEANS, CITY OF NEW ORLEANS.

BE IT KNOWN, That on this Fifth day of October, in the year of Our Lord, One thousand nine hundred and six, and of the Independence of the United States of America, the one hundred and thirty first...

ARTICLE I. The name of this corporation shall be the NEW ORLEANS MANUFACTURING AND EXPORT COMPANY, and under its said corporate name it shall have power and authority to have and enjoy corporate existence for the full term and period of ninety-nine years, from and after the date hereof...

ARTICLE II. The domicile of this corporation shall be in the City of New Orleans and the State of Louisiana, and the principal office of the same shall be served on the President of said Corporation...

ARTICLE III. The capital stock of this corporation is hereby authorized to be increased from the sum of \$1,000,000 to the sum of \$2,000,000, divided into 200,000 shares of \$10.00 each...

ARTICLE IV. The Board of Directors of this corporation shall be composed of not less than five and not more than fifteen directors, who shall be elected annually on the 5th day of October...

ARTICLE V. Whenever this corporation may be dissolved, either by its own act or by any other part of its property for cash or on terms of sale or otherwise...

ARTICLE VI. This act of incorporation may be modified, changed or altered or this corporation may be dissolved, with the consent of three-fourths of the capital stock represented at the general meeting of the corporation...

ARTICLE VII. No stockholder shall ever be held liable for the contracts or debts of said corporation to the extent of the amount of the shares of stock owned by him, nor shall he be liable for the debts of said corporation...

STATE OF LOUISIANA, PARISH OF ORLEANS.

Be it known, That on this fourth day of September, in the year of Our Lord, one thousand nine hundred and six, before me, J. C. DAVEY, Jr., a Notary Public in and for the Parish and State of Louisiana, personally came and appeared, A. C. Wuerpel, a resident of this city and president of the New Orleans Land Company, a legal corporation of this city and State, created by Act No. 149 of the Legislative Session of 1894...

ARTICLE I. The capital stock of this corporation is hereby authorized to be increased from the sum of \$1,000,000 to the sum of \$2,000,000, divided into 200,000 shares of \$10.00 each...

ARTICLE II. The Board of Directors of this corporation shall be composed of not less than five and not more than fifteen directors, who shall be elected annually on the 5th day of October...
