CHARTER
UNITED STATES OF AMERICA STATE
OF LOUISIANA PARISH OF OR-
LEANS, CITY OF NEW ORLEANS.
BE IT KNOWN, That on this Thirtieth
day of October, 1906, the year of
Our Lord One thousand nine hundred and six,
and of the Independence of the United States
of America Ninety one years, and twenty
sixth before me, ERNEST TOULOU
MAYOR, a notary public in and for the Parish
of Orleans State of Louisiana, duly commis-
sioned and qualified, and in the presence of
the witnesses hereinafter named and under-
signed, personally came and appeared the
persons whose names are hereinafter subscribed,
who severally declared that availing them-
selves of the provisions of the laws of the
State of Louisiana relative to the organization
of corporations and especially of Act No 36
of the Session of the General Assembly of
said State for 1888, they have formed and
organized and do by these presents form
themselves, their successors and assigns, into
and constitute a corporation for the objects
and purposes herein set forth, and that the
agreements hereinafter set forth, which they
herby adopt as their charter, to-wit:

ARTICLE I.
The name and title of the corporation hereby
formed is declared to be THE H. W. SLOAN
COMPANY, LIMITED, and the same shall
continue in force for a period of ninety-nine
years, and shall have the same powers,
rights and privileges as are conferred by
law upon corporations.
ARTICLE II.
The domicile of this corporation shall be in
the Parish of Orleans, Louisiana, and all citi-
zens or other legal process shall be served on
the President of the Company, or in his ab-
sence, on the Secretary or Treasurer.
ARTICLE III.
The objects and purposes for which this cor-
poration is organized and the business of the
same to be carried on or to be hereafter de-
clared to be the conducting of the business of
purchasing and selling, or either on orders,
and the carrying of cotton and other commodi-
ties, to set as agent or attorney in and for
the purchase of purchasing or selling or ex-
porting cotton and other commodities, to buy,
transfer, convey or otherwise dispose of any
kind of property that may be owned by the
corporation or incorporated, chosen in stocks,
notes, bills of exchange, or otherwise, to
borrow money and to give mortgages and to
pledge and use any property belonging to it ; to
 sue and be sued in its own name, or its own
account, or for the account of others.
ARTICLE IV.
The capital stock of this corporation is here-
by fixed at ten thousand dollars (\$10,000.00)
divided into one hundred shares (\$100.00
par value) of one hundred dollars (\$100.00)
each, which said shares shall be paid for in
cash, or by promissory notes, or by other
property at the time that the same shall
be issued. All transfers of stock shall be made
in the books of the Company and shall be
valid only when countersigned by the Secretary
of the Company and the Treasurer.
ARTICLE V.
All the corporate powers and authority of
this corporation shall be vested in a Presi-
dent, a Secretary and an Assistant Secre-
tary, who shall constitute a Board of Di-
rectors, and shall be elected at an annual
meeting of the stockholders to be held on the
second Monday of January of each year.
ARTICLE VI.
All elections shall be by ballot, and held at
the office of said corporation, under the au-
thority of two commissioners to be appointed
for that purpose by the Board of Direc-
tors, and the election shall be by ballot, and
each elector shall be entitled to vote either
in person or by proxy, and a majority
of the votes cast shall be the right and valid
decision, and in case of a tie, the election
shall be decided by a majority of those
present. Until the said first annual meeting
of the Board of Directors of this Company, to-
wit: the said H. W. Sloan, President, and J. P.
Sloan, Secretary and N. P. Sloan, Treasurer,
with the said H. W. Sloan as President, and
J. P. Sloan as Secretary and N. P. Sloan as
Treasurer.
ARTICLE VII.
No stockholder shall ever be held liable or
responsible for the contracts or debts of this
corporation in any further amount than the
amount of the stock or shares owned by
him, nor shall any mere
informality in organization have the effect of
rendering the stockholder liable for any
amount in excess of the amount of his stock.

ARTICLE VIII.
At the termination of this charter by limi-
tation or otherwise, the business and affairs
of this corporation shall be liquidated by two
commissioners to be appointed from among
the stockholders at a meeting convened after
ten days prior notice in writing, and shall
begin to act on the day of the meeting, and
