STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS

BE IT KNOWN, That on this fifth day of October, in the year of Our Lord one thousand nine hundred and six, and of the Independence of the United States of America, the one hundred and sixth day...

ARTICLE I. The name of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY and under its said corporate name it shall have power and authority to have and enjoy corporate franchises...

ARTICLE II. The objects of this corporation shall be to manufacture, produce, sell and export in Louisiana, all or other legal process shall be served on the President of said Corporation...

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be to buy, hold, maintain and improve...

ARTICLE IV. The capital stock of said corporation is hereby fixed at the sum of one million dollars (\$1,000,000) divided into and represented by 500,000 shares of stock of the sum of One hundred and twenty dollars each...

ARTICLE V. All the corporate powers of said corporation shall be vested in and exercised by a Board of Directors to be composed of three stockholders to be elected annually on the first day of January...
