STATE OF LOUISIANA PARISH OF ORLEANS CITY OF NEW ORLEANS

BE IT KNOWN That on this Fifth day of October in the year of our Lord One thousand nine hundred and seven...

BEFORE ME JOHN G. ESTES, a notary public in and for the Parish of Orleans, State of Louisiana, aforesaid, and in presence of the witnesses hereinafter named and named personally came and appeared the several persons whose names are hereunto subscribed, who severally declared that availing themselves of the law of the State of Louisiana...

ARTICLE I

The name of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY, and under said corporate name shall have power and authority to have and enjoy corporate existence for the full term and period of years hereinafter expressed...

ARTICLE II

The domicile of this corporation shall be in the City of New Orleans and the State of Louisiana, at all times and in all places...

ARTICLE III

The objects and purposes for which this corporation is organized and established shall be to buy, sell, lease, and otherwise dispose of real and personal property...
