SUBJECT: 20 January 2010 Detainee Review Board (DRB) Recommendation for Continued Internment Disapproval for ISN 4259

1. I reviewed the findings and recommendation of the DRB conducted on 20 January 2010 concerning the internment of Detainee ISN 4259. After consideration, the DRB's recommendation that ISN 4259 continue to be detained at the Detention Facility in Parwan is disapproved to the extent that he can be transferred through the Aloko process.
2. The board's recommendation that ISN 4259 meets the continued internment criteria was flawed. Another detainee's fingerprints were incorrectly attributed to ISN 4259. A board member's voting sheet specifically cites the biometric match relating to ISN 4249 and mistakenly attributes that evidence to ISN 4259. The mistaken conclusion that the biometric evidence related to ISN 4259 was specifically cited as a reason for continued internment. Another member cited that continued internment was necessary because ISN 4259 may have known a member of the Taliban. Both votes and the board's decision are legally insufficient on their face. Further, there is no specific evidence that establishes anything more than that he might know persons associated with the Taliban.
3. I direct that ISN 4259's case file be prepared for review by the Aloko Commission for reintegration purposes.



1. I reviewed the findings and recommendation of the DRB conducted on 11 February 2010 concerning the internment of Detainee ISN 1001. This case is based on reporting that Hafizullah supplied the Taliban with emergency medical assistance and supplies on 23 August 2003, 4 days before his capture. He denies that this ever happened and there was no evidence recovered at the scene of capture to corroborate this allegation. In addition, there is no evidence that Dr. Hafizullah provided medical supplies outside of the emergency care rendered to Taliban members.
2. I find that even if Hafizullah treated persons wounded on the battlefield, he acted to a general humanitarian obligation. At the same time, he had an obligation to report Taliban activities to the authorities.
3. Given the lack of evidence in this case, the extenuating circumstances of his alleged support to the Taliban, and his 18 months at the DFIP, there is little to no chance he would be charged if transferred to ANDF. Accordingly, I direct that he be reintegrated into the Afghan community.

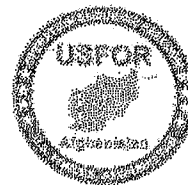

1. I reviewed the Brigade Surgeon, Task Force Protector's Recommendation for Consideration for Medical Humanitarian Release for ISN 3978 dated 15 February 2010. ISN 3978 is elderly and continued detention may place him at risk. He carries a constellation of medical problems including diabetes, hypertension, heart disease, and history of stroke. He is 67 years old.
2. Based on reports, Haji Katlai was targeted and captured 18 March 2009 on a US-assisted Afghan National Directorate of Security (NDS) raid in Pul-e-Alam District, Logar Province. Reporting indicated that Haji Katlai is a well known insurgent and influential business man in the Logar and Kabul Provinces. The reports alleged he provided financial support for the insurgency with the money, and uses his hotel to support of suicide bombing operations.
3. A DRB held on 18 November 2009 recommended continued internment. Medical information was not before the board. At his board, he admitted to ownership of a rifle and shotgun found at his compound, and claimed he had permission to own them. On 13 December 2009, the Convening Authority approved the DRB's recommendation and found continued internment necessary.
4. After consideration, and consistent with the Brigade Surgeon's recommendation, I recommend ISN 3978's humanitarian release. Nearly all reporting predates his illness and is from between 2005 - 2008. The assessment that he is a continuing threat is mitigated by his age and deteriorating health.
