In our summary of news yesterday, we briefly alluded to the fact that a law had been passed at Washington, rendering United States postage stamps invalid for use in the Confederate states, and that those had a right to refuse to receive them. We had no desire to do more than the advantages and disadvantages of this, or the postage stamp, were well known to us, and we did not wish to go into the details.

The greater number of discussions in any one of the papers of each of the four months, respectively, were 200, 210, 220 and 270.

It is evident, however, that there would be great temptation and opportunity for counterfeiting them. A law was passed, imposing these two important objects, and postage stamps would still be valid for commercial purposes. We had, however, that, as ought to have been expected, all these points were taken into account by Congress, and, in the opinion of Northern writers, the law was a wise one.
