BE IT KNOWN That on this Fourteenth day of the month of December, in the year of our Lord One thousand nine hundred and ten...

ARTICLE I. The name and title of the corporation hereby formed is to be JOHN A. ALMINA COMPANY LIMITED under which name it shall have and enjoy corporate existence for the period of twenty years...

ARTICLE II. The domicile of this corporation shall be in the City of New Orleans, Louisiana. All action or other legal process shall be served on the President of the Company or, in his absence, on the Vice President, or Secretary and Treasurer.

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be the carrying on of a general grocery and commission business...

ARTICLE IV. The capital stock of the corporation is hereby fixed at the sum of five hundred thousand dollars (\$500,000) divided into one hundred and twenty shares of five hundred dollars each...

ARTICLE V. All the corporate powers and authority of the corporation shall be vested in a President, a Secretary and Treasurer and two Directors who shall constitute a Board of Directors...

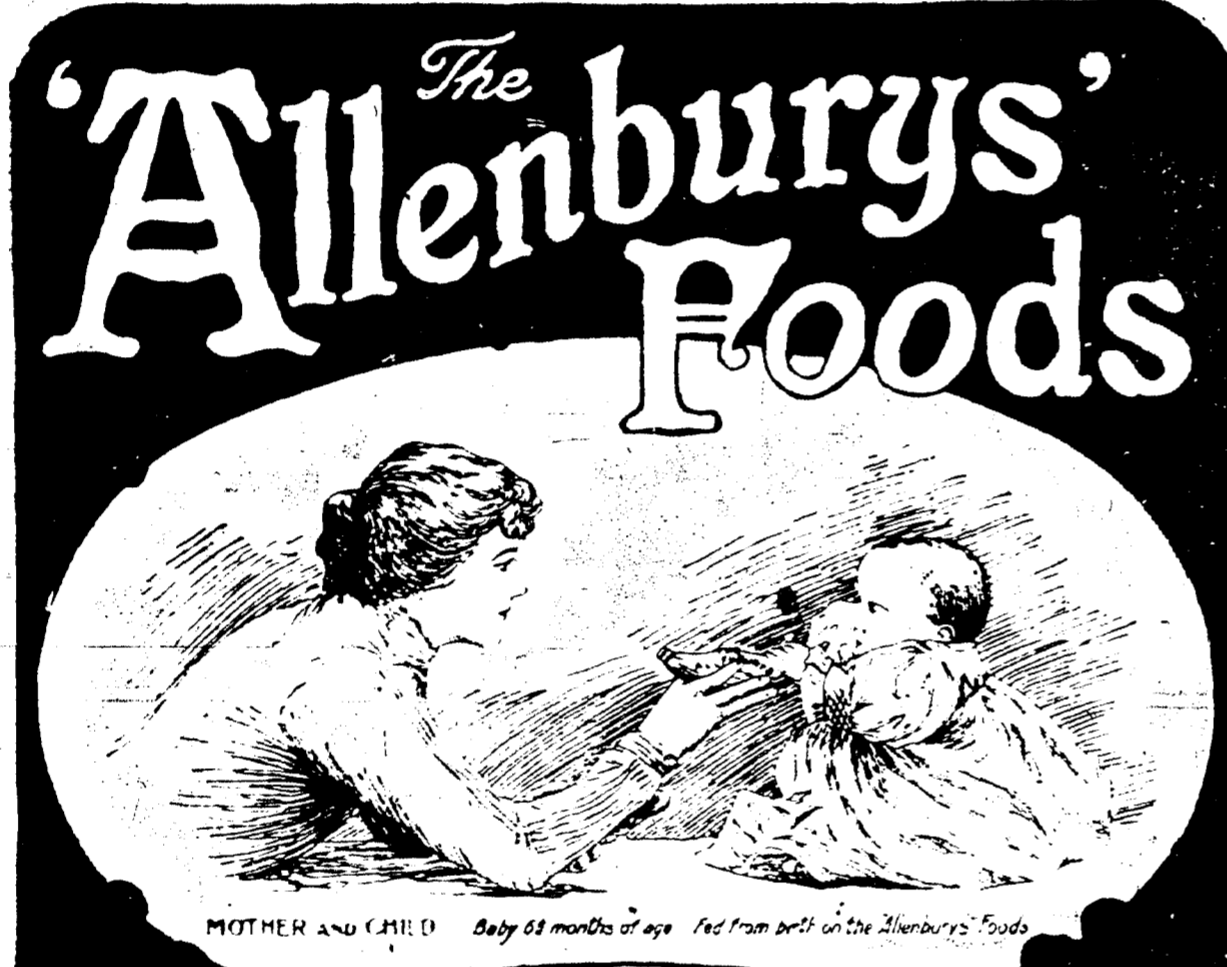
ARTICLE VI. All elections shall be by ballot and held at the office of said corporation, and the same shall be held for the purpose of electing a President, a Secretary, a Treasurer and two Directors...

ARTICLE VII. Both the stockholders subscribing to this charter and the stockholders who hereafter may purchase or otherwise acquire shares of stock in this corporation shall have the right to vote at all annual meetings...

ARTICLE VIII. No stockholder shall ever be held liable for the debts or contracts or liabilities of the corporation to any further amount than the unpaid balance due to the corporation on the shares owned by him...

ARTICLE IX. At the termination of this charter by limitation or otherwise, the business and affairs of the corporation shall be liquidated by three commissioners to be appointed from among the stockholders...
