## OFFICIAL REPORT

PROCEEDINGS OF THE SENATE OF LOUISIANA

OF FRIDAY, FEBRUARY 10, 1843.

On motion of Mr. Davison, the bill granting leave of absence to James E. Jones, Judge of the Eighth Judicial District, was read for the first time.

Mr. Ansley desired to know what was the necessity that required the absence of two functionaries from his post at the same time, and he was told that it was of a temporary nature, he would himself be bound to vote against it.

Mr. Davison explained that this leave of absence was granted to him by the Judge of the Eighth Judicial District over which Judge Jones presided, on account of the date and previous state of health of the latter. That the two functionaries were absent either by death or resignation, and they were induced to hold a session of the Senate at a time when the State could not afford to lose their services.

Mr. Ansley said he intended to vote against the bill, but after other similar applications for leave of absence, he thought it necessary in order to prevent misconstruction, to make a fortunate one for so doing.

He did not like the pleasure of being personally acquainted with the author of the bill, and therefore did not give his opinion of him, but his character was held in the greatest estimation. He, therefore, had no motive but that of public duty to oppose the bill.

On motion of Mr. Davison, was laid over till the second reading, and on motion, was referred to the Recorder of Mortgages in the Parish of St. Landry.
