Mr. Ponyavin:

It has come to our attention that you constantly attempt to discredit our international non-profit public-benefit organisation, the International Delphic Council e.V. (IDC) registered in Berlin / Germany.

As you know, the IDC was founded in Berlin/Germany in 1994 as the first and only legitimate international organisation representing the Delphic Games on a worldwide level. The so-called “*International Delphic Committee*”, on the other hand, was founded ten years later, emerging from the so-called “*NDC Russia*”. And the “*NDC Russia*” used to be a member of our umbrella organisation, the IDC in Berlin.

You ignore these well known facts and – according to independent and reliable information sources – tell other people lies about our organisation. For example: Not only did you write to Mr. TULPANOV in 2005 that the IDC misrepresents the history of the Delphic Movement, but also did you try to “torpedo” our Delphic Games in Malaysia and our negotiations with South Africa on Delphic Games in the future.

Further, a new website www.IDCworld.org was recently launched which contains misleading information and ultimately leaves the wrong impression that you are the sole and true representative of the Delphic Games at worldwide level. Such claim is without substance and might cause international frictions as well as a violation of our intellectual property rights.

The IX Amphictyony Meeting, held in Berlin on 25/26 January 2007, (IDC Executive Board Meeting), therefore decided to demand for a declaration (i) that you withdraw from all such illegal actions and (ii) that you will from now on officially accept the IDC in Berlin as a legitimate international organisation representing the Delphic Games on a worldwide level.
