Mission Statement

The **DELPHIC COUNCIL SAINT-PETERSBURG** shall undertake active efforts aimed at the sponsorship, establishment and promotion of numerous Delphic Clubs for adults, and Junior Delphic Clubs for young people, formed at the city, province and regional levels within the geographic area of Russia, with unified or diversified cultural specialities, as the 'grassroots' foundation activity to support the cultural and educational aims of the IDC.

Additionally, the **DELPHIC COUNCIL SAINT-PETERSBURG** shall be authorised to undertake, at his discretion, all form of discussions and negotiations with any parties which, in his opinion, could lead to progress in the above specified activities, and other activities and situations related to the IDC.

In the performance of these duties, the **DELPHIC COUNCIL SAINT-PETERSBURG** shall regularly consult with the Secretary-General of the IDC and report on the progress of his activities. The official operating languages of the IDC are German and English. Translations of this document into other languages are for information purposes only.

The Power and Authority – according to the Statutes, Charter, pending By-Laws and Resolutions of the Executive Board and World Congress of the IDC – conferred herein shall be unlimited.

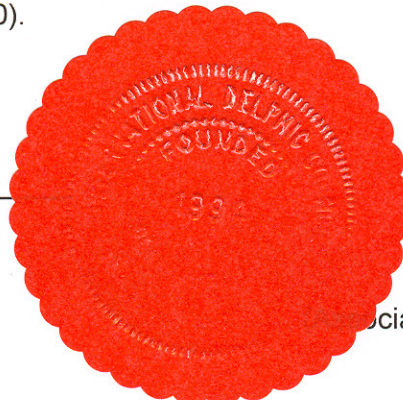
