The mail of yesterday brought us papers from New York of the 16th inst. from Washington of the 14th, yet from Charleston only of the 14th inst. of the 6th.

Intelligence of very little moment had been received by an arrival in New York from Liverpool; the particulars are however extracted.

Riots and consequent murders were rife in New York, owing to the animosity excited against the Irish there, having interfered in elections. Naturalization conferring the right of suffrage may be too in New York; but this is an improper remedy. Whatever is done should be by law.

By the way, some of the assent journals seem in error, when they assert that every state in the union has a legal right of interest, except Louisiana.
