SUBJECT: (S) Recommendation to Retain under DoD Control for Guantanamo Detainee, Mo Amad Gui, ISN: US9AF-000456DP

1. (S) **Personal Information:** Mo Amad Gui is an Afghan national born in 1974 (age 29) in Kandahar, Afghanistan (AF). He has been diagnosed with latent Tuberculosis, but is otherwise in good health.
2. (S) **Detention Information:** Subject detainee was taken into custody by Pakistani (PK) authorities in Girdi Jangle, PK under suspicion of being a Taliban supporter and on weapons possession. Detainee was found to have two AK-47's in his home and a weapon permit signed by the Taliban Governor of Kandahar, AF. Detainee was turned over to US custody and was subsequently transported to Guantanamo Bay Naval Base, Cuba on 12 June 2002 because of his suspected involvement with the Taliban.
3. (S) **Reasons for Detention:** Detainee is suspected of being a Taliban supporter. The detainee and his brother are suspected of drug and weapons smuggling that supported the Taliban directly. When questioned concerning these issues the detainee has not been forthright and has repeatedly been found deceptive. The detainee, in part because of his deception, has been not been fully exploited and currently has eight HCRs levied against him.
4. (S) **Assessment:** Based on information collected and available to Joint Task Force Guantanamo as of 22 September 2003, detainee ISN: US9AF-000456DP is assessed as not being a member of Al-Qaida nor a Taliban leader. Moreover, based on the detainee's folder, the knowledgeable brief, and subsequent interrogations by JTF Guantanamo, the detainee is of intelligence value to the United States. Based on the above, detainee poses a medium threat to the U.S., its interests or its allies.



SUBJECT: Recommendation to Retain under DoD Control for Guantanamo Detainee, Mo Amad Gui, ISN: US9AF-000456DP

5. (S) **Recommendation:** In view of the foregoing, I recommend subject detainee be retained under DoD control.

6. (C) **Coordination:** JTF Guantanamo notified the Criminal Investigative Task Force of this recommendation on 18 August 2003, who recommended on 6 November 2003 that the detainee be retained in DoD control and categorized the detainee as a low risk. In the interest of national security and pursuant to the agreement between the CITF and JTF GTMO Commanders, CITF will defer to JTF GTMO's assessment that the detainee poses a medium threat.
