Reference: Deputy Secretary of Defense Memorandum: Policy Guidance on review Procedures and Transfer and Release Authority at Bagram Theater Interment Facility (BTIF) Afghanistan (2 Jul 09)

- 1. Gullistan, ISN 3818, is a Pakistan national captured by U.S. Forces on 4 July 2009. He is currently detained at the Detention Facility in Parwan. A Detainee Review Board on 23 March 2010 found that isn 3818 does meet detention criteria, but recommended that ISN 3818 be transferred to Pakistan Authorities for their consideration of participation in a reconciliation program. After my Staff Judge Advocate reviewed the board proceedings and found them legally sufficient, I approved the Board's finding and have directed that Gullistan be transferred as soon as practicable.
- 2. Per the reference, because the detainee is a third country national, return to his home country, Pakistan, requires approval by the Deputy Secretary of Defense or his designee. The reference also states that recommendations for transfer and repatriation shall be transmitted Under Secretary of Defense for Policy, through the Director, Joint Staff. The Office of the Secretary of Defense is to ensure that recommendations are coordinated with the Department of State prior to seeking approval from the Deputy Secretary or his designee. Trecommend approval of this transfer and repatriation and hereby seek disposition for further action in accordance with the reference.
