



Jurisdiction: Why Does it Matter?

- Affects what law applies...for WMF, it is U.S. law
- Strong protections under U.S. law
 - First Amendment
 - DMCA Safe Harbor, CDA 230, and SPEECH Act of 2010
- Affects ability to provide content without wrongful government censorship, lawsuits, and fines.
 - For example: lese-majeste laws in Thailand
- Some unfortunate restrictions under U.S. law
 - E.g., Golan decision





May a user post a video containing audio derived from an unlicensed MIDI @?^[1] Short for Musical Instrument Digital Interface, a MIDI file contains instructions (such as musical notation, pitch, volume, instrument type, etc.) that are utilized by a synthesizer to generate sound.
