STATES OF LOUISIANA PARISH OF ORLEANS, CITY OF NEW ORLEANS. BE IT KNOWN, That on this fifth day of October, in the year of our Lord, One thousand nine hundred and seven...

ARTICLE I. The name of this corporation shall be the CONSUMERS LUMBER MANUFACTURING AND EXPORT COMPANY, and shall have power and authority to buy and sell...
