# Navy extends early transition program for FY06

WASHINGTON (NNS) — The Navy is again offering Sailors whose active-duty obligated service (EAOS) ends before Oct. 1, 2006, the opportunity for early separation under another installment of the Early Transition Program.

“With the continued high reenlistment rates and low attrition rates, the Navy can continue to extend this early transition option to our Sailors,” explained Vice Adm. John C. Harvey, Jr., Chief of Naval Personnel. “Sailors have the opportunity to continue service to their country through the Navy Reserve. They may also continue service in the Army through the Blue to Green program.”

Sailors interested in early transition must request a separation date no later than Aug. 15. All requests must be received by PERS-4832 not later than Aug. 1 through their commanding officers. Commanding officers have final disapproval authority for all requests and may grant separation leave, but permissive temporary duty and involuntary separation pay are not authorized.

Sailors who are enrolled in the Montgomery GI Bill program will receive one month of benefits for each full month served on active duty up to a maximum of 36 months. Those discharged under this program who have served 20 months of a two-year enlistment or 30 months of a three-year enlistment will receive 36 months of benefits.

For the first time, Sailors who received

an enlistment bonus may request a waiver of repayment for the portion of the bonus for active-duty time not served. Waiver requests must be made as outlined in NAVADMIN 022/06 or repayment will be automatic.

This voluntary program applies to most Sailors in the active, reserve, full-time support and canvasser recruiter communities. However, it does not apply to selected reserve Sailors (including mobilized reservists), those Sailors under a selective reenlistment bonus or eligible for SRB reenlistment contract. Also ineligible for the early transition are those in the nuclear ratings, SEAL, SWCC, EOD, or Diver pro-

grams or who enlisted under the National Call to Service program.

All Sailors are encouraged to consider service in the Navy Reserve once their active-duty time is complete.

The Blue-to-Green program also provides transitioning Sailors the opportunity to make a seamless switch to the active-duty Army with no break in service. Both of these options are available for Sailors taking advantage of the Early Transition Program.

## Students still contributing to Katrina relief

Students at W.T. Sampson High School continue to help Mississippi’s hurricane victims in a unique student relief initiative called “Pirates Helping Pirates”.

The idea for the program came when students and faculty at the high school here decided to adopt a school that had been severely damaged by Hurricane Katrina.

W. T. Sampson was assigned Pass Christian Public School in Mississippi, and came up with a name for the program when they realized both high schools’ mascots were pirates.

W. T. Sampson information specialist, Neata Wiley said once the students saw the devastation that hurricane Katrina caused, they were eager to help.

“They have been so gracious and so giving,” Wiley said. “You feel like you’ve gone to the well one too many times, but

people have just given and given.”

Since October, the students have raised more than \$3,000 for hurricane relief for the Pass Christian Pirates with events ranging from a bowl-a-thon, to car washes.

The W.T. Sampson faculty also put together a program to help Pass Christian girls get prom dresses. GTMO residents have donated gowns and money to send so that less fortunate girls can choose a gown for free. Teachers collected 32 gowns and \$100 in donations.

“We feel like the girls who can’t get their own dress will have a way to go to the prom now.” Wiley said.

Wiley said students and faculty have plans for a Tae Kwan Do demonstration, a 5K run, and more car washes and bake sales to help them reach their \$5,000 goal before the school year ends. She said the program is about \$1,400 short.

# Barracks renovations given a high priority

Officials here have recently received word from Commander of Naval Installations (CNI) that renovation projects here will be given high priority through fiscal year 2008.

While construction crews begin preparing the Gold Hill Towers for phase one of what base officials are calling a much-needed renovation project, the Naval Station's senior leadership can already begin looking forward to the second and third phases of renovations on the barracks that have seen obvious deterioration from years of use.

Construction is slated to begin next month on the barracks renovation, and CDR Jeff Johnston, Public Works Officer, is saying this is just the beginning of a long-term project that has been in the works for at least three years.

The Gold Hill Project received funding late last year, fiscal year 2005, for the renovation phase that will begin next month, and phase two of the project is fourth on CNI's priority list for all naval installations world-wide. Phase three has been guaranteed high priority for fiscal year 2008.

"We are very pleased to see a firm funding commitment from CNI for the next two phases of Gold Hill Towers," Johnston said. "This means that there will be work going on in Gold Hill pretty much constantly from now for the next four years, maybe even a little bit longer."

While the project will clearly be time-consuming, Johnston assured the process of renovating the worn barracks will be thorough, taking full advantage of CNI's decision to make the repairs

to the building a priority.

"There's a lot to do and certainly, given this opportunity, we don't want to cut any corners," said Johnston. "This is our opportunity to get in and make Gold Hill the way it needs to be, and we are going to take every opportunity to make that happen."

Housing official Marie Goode-Spencer agreed that the renovations were needed. She said that even when the renovations were completed, because of the antiquated configuration (facilities like communal bathrooms) the building will still house third-country nationals and other foreign employees.

Johnston also said the cost of the renovation will not deter the base from continuing to pursue upgrades to family housing, saying the funds for this project come from a separate pool of money.

Goode-Spencer said more

family housing upgrades are coming this fiscal year.

Public Works has made plans to ensure the construction process will cause as little disruption as possible to the traffic to the Gold Hill Galley, but Johnston acknowledges that some effects will be felt throughout the Naval Station. He says in the

end, the trouble will be well worth it.

"I ask everybody, if we all pull together, at the end of the day, or many, many days, the base will be left with a much, much better facility, and will be the first step of a long journey to better way of life," said Johnston.

# Corporate partners offer free tax filing service to military members

WASHINGTON (NNS) — Military members and their families can now file their taxes for free, thanks to a partnership between a group that helps military people deal with financial issues and a civilian financial services company.

"Military OneSource" has partnered up with Intuit, a financial services company, to provide the TurboTax basic product for federal and state returns at no cost. Military members can download this program and also benefit from tax consultations and have access to appropriate resources. The Military OneSource Web site will provide annual upgrades to the TurboTax software at no cost.

"This tax consultant support for filing 2006 taxes is available telephonically toll-free (800-342-9647) and at no cost to the service members from any deployment location in the world," acting Deputy Undersecretary of Defense for Military Community and Family Policy Jane Burke said. "Military OneSource tax consultants are also familiar with the IRS publication 'Armed Forces Tax Guide.'"

Burke said DoD has a long history of offering tax assistance to military members, but this year the department is offering the opportunity for service members to self-file electronically at no cost, using a popular software product that double checks for accuracy.

"For many years, help has been available at many installations through the Voluntary Income Tax Assistance program. VITA volunteers will continue to be available through legal centers at most installations. VITA volunteers



help service members to file their taxes free of charge," said Burke.

Defense Department personnel noticed the need for a tax filing system that met military members' needs. TurboTax modifies itself based on the customer's information relevant to their unique tax situation. Providing an easier way to file taxes is an important quality-of-life issue, officials said.

"DoD recognizes the reciprocal relationship that binds the military member, the military mission, and military families. The Department is working hard to make a difference in the quality of life of service members and their families," Burke said. "The Military OneSource program, available worldwide 24/7, leverages technology to

help service members and their families deal with the stresses of the military lifestyle. Providing access to electronic tax filing with the free telephonic support of a tax consultant is just one of the services offered by the Military OneSource service."

Tax customers can expect to see a new and improved way of filing their taxes as well. The easy-to-understand language allows users to feel more confident about the information they receive. Users can also click on an "Explain This" button within the TurboTax Web site to get relevant help. TurboTax also includes time-saving summary screens, allowing users to quickly review and edit their data.

"The department is proud to offer innovative options, like free electronic access to TurboTax and telephonic support, for addressing the challenges that military members and their dependents face. The Department of Defense recognizes that families also serve and is committed to supporting military families," Burke said.

# Military spouses can now apply for financial counselor fellowship

MILLINGTON, Tenn. – Military spouses interested in the financial counseling field can apply for one of 200 fellowships being offered for the Accredited Financial Counselor Program. Applicants interested in the program must apply online at [www.nmfa.org](http://www.nmfa.org) before the closing date of Feb. 14, 2006.

This program is being offered through the Association for Financial Counseling and Planning Education (AFCPE), in partnership with the National Military Family Association (NMFA) and the NASD Investor Education Foundation.

"The purpose of this program is to provide 200 military spouses with the education necessary for entry into the financial counseling field," said David DuBois, program manager for Military Career Readiness Programs, Commander Navy Installations (CNI) Command, Washington, D.C.

"The fellowship covers the educational costs of the program, which includes registra-

tion, tuition and study materials for the two courses and one attempt at each of the two exams. This self-study program can take up to 18 months to complete," DuBois added.

"Upon successful completion of the educational, testing and experience requirements, the participant will be awarded the Accredited Financial Counselor designation from AFCPE."

Applicants must be current or surviving spouses of active duty or retired Army, Navy, Air Force, Marine Corps, Coast Guard, Army or Air National Guard or reserve component service members.

"This program is unique in that it not only helps military spouses achieve career goals and aspirations by enhancing job-related marketability, it also benefits military family members by enhancing their personal financial management skills," said DuBois.

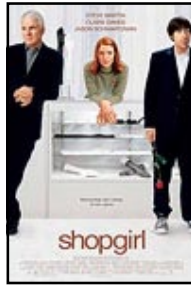

# DoD sets CFC record with charitable giving

WASHINGTON, Jan. 24, 2006 – The Defense Department raised a record-high \$15.1 million in the 2005 Combined Federal Campaign, exceeding the department's goal by \$2.3 million.

DoD recognized its organizations for their fund-raising efforts Jan. 24 at the Combined Federal Campaign awards ceremony in the Pentagon.

"By all of these contributions, you have enabled the Department of Defense to main-

tain its distinction as the largest single charitable organization in the world," Michael B. Donley, director of administration and management for the Office of the Secretary of Defense, said to the ceremony participants.

DoD participation in the Combined Federal Campaign was 60 percent, which is about 10 percent higher than the average of other federal agencies, Donley said. Twenty-three of the 24 DoD organizations that

participated in the campaign earned the National Capital Area unit award for their achievements, he added.

The Combined Federal Campaign is a nationally authorized workplace-giving drive of federal employees. Employees are given the opportunity to contribute to hundreds of different charitable organizations by way of a payroll deduction or one-time payment.

When this year's Combined Federal Campaign began, offi-

cialists were concerned that people would be tired of requests for donations after the numerous natural disasters this year, but DoD employees exceeded expectations and demonstrated their giving nature.

"The president talks about the great people in America and how generous they are, taking care of neighbors, and it is what America's all about," said Deputy Defense Secretary Gordon England. "You've all done a wonderful job."
