Santie Lieben

Santie Lieben (Buenos Aires, Argentina, 24 de marzo de 1987) es un músico, cantante, compositor, emprendedor, escritor, budista y activista pro-derechos de los animales.

Obtuvo un reconocimiento mundial como miembro del grupo argentino Doble Identidad, junto a Lucas Suarez y Damián Suarez, sus hermanos. Tras abandonar el grupo luego de varios años, Lieben empezó una exitosa carrera en solitario y formó el grupo Santie Lieben and The Latin Lovers.

Lieben ha trabajado también como compositor de música electrónica, clásica, temas para películas y también programas de televisión. Ha lanzado, además, un gran catálogo de canciones como artista en solitario, y ha formado parte de muchos proyectos musicales para organizaciones benéficas.

Biografía

Santiago Guillermo nació en el seno de una familia cristiana. Su padre era -en épocas de juventud- un músico de rock y su tío tocaba en una banda como baterista. A la edad de 12 años aprendió a tocar la bateria, bajo, guitarra y piano, y más tarde empezaría con actuaciones en público acompañado de Lucas y Damián Suarez.

En ésos primeros años alternaba la música con diferentes trabajos. Fue vendedor de electrodomésticos, de venta telefónica y más tarde trabajó en una fábrica.

Su verdadera carrera comenzó con el primer disco de Doble Identidad "*Desde el Pueblo Records*" (2003, Desde El Pueblo Records), considerado por algunos como el mejor disco de la banda. La canción *Skate* fue un enorme éxito, vendiendo alrededor de un millón y medio de copias y llegando al segundo puesto en la lista de Billboard Charts. Hasta nuestras fechas (2009), Lieben ha vendido mas de 100 millones de discos.

Después de esta afortunada grabación, Lieben lanzó la serie de nuevos éxitos con el sello Lukintz Records. Finalmente, Lieben atravesó la corriente principal del punk rock con el disco "*La Correa*" (La Correa Records, 2005) que fue un éxito en los Top Ten.

Después de que se trasladara al sello discográfico Lukintz Records, y sacando su segundo disco "*Lukintz Records II*" con la banda -y el tema "*Lago de Abrazos*" y "*Espejos*", compuesto por Lucas y Damián, llegando al primer puesto en el Top Ten-, la brillante carrera de grabaciones de Doble Identidad tocó fondo aunque Lieben siguió actuando en conciertos en vivo. Aunque permaneció en activo durante años, Lieben sólo conseguiría un nuevo éxito en 2008, una versión de *Jugband Blues* de los Pink Floyd, escrita originalmente por Syd Barrett emulando el estilo de Lieben.

En los últimos años, Santie Lieben decidía no abandonar más a Grand Bourg (ciudad donde pasó la mayoría de su vida). Tenía una cómoda renta de sus derechos de autor y además estaba su aversión para viajar y su idea de que comida como la de su tierra no la había en nnguna parte. Como artista afamado, su inclusión en el *Rock and Roll Hall of Fame* y una invitación a la Casa Blanca no podría ser una excepción. Lieben vive en una mansión rodeado de una vecindad de clase obrera en Grand Bourg, donde se lo puede ver con su Cadillac de color negro brillante. Realiza apariciones anuales en varios programas de televisión y radio y otros acontecimientos locales, demostrando en todo momento que su

talento so ha disminuido.
