Shri K. C. Jain Departs



We have to report with great sorrow that Shri K. C. Jain, our Legal Adviser, left for his Heavenly Abode on 12th October, 1967. Late Shri Jain had long associations with Dalmia Group of Industries and his devoted services to Dalmia Enterprises would be remembered for all times to come. Besides being a renowned legal expert, Shri Jain was very social by nature and had an affectionate heart for all.

Shri Karam Chand, popularly known as Shri K. C. Jain, was born on 5th January 1898 at Rewari, Dt. Gurgaon. Shri Jain had his College Education in St. Stephens and Hindu Colleges of Delhi and had taken his Law Degree from Lahore in 1920 securing second position.

Late Shri Jain had started his legal practice at Gurgaon in 1920 and soon rose to prominence. From 1931 till the dawn of Independence Shri Jain had served as Public Prosecutor and in recognition of meritorious services, he was awarded the title of 'Rai Sahib' in 1945. After Independence, when the Special Police Establishment was set-up, he became their first legal Adviser.

After serving the Govt. for about 20 years Shri Jain once again felt inclined to join the Bar. For over 16 years he had been the Legal Adviser of Dalmia Enterprises and was a pillar of strength to the organization.

His untimely death on 12.10.'67 has left a void in the legal profession, which is difficult to fill up. He was a great champion of all causes which concerned the amelioration and betterment of the profession. He was most dignified and bold in the presentation of his client's cases.

A condolence meeting was held at Head Office New Delhi on 16th October, 1967, wherein Shri V. H. Dalmia read the following condolence resolution—
