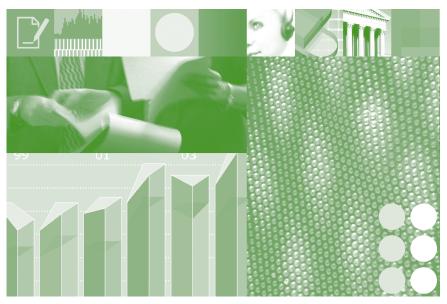

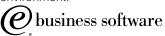
### IBM DB2 Records Manager for Content Manager QuickStart

a records management solution using IBM DB2 Records Manager, as the control solution, and IBM DB2 Content Manager for Multiplatform, for the document repository. This includes the Records Manager Enabler for Content Manager, the integration link between DB2 Records Manager and DB2 Content Manager for Multiplatform. Your IBM consultant will work with your administration and support staff to transfer skills and offer guidance focused on getting you up and running quickly. At the conclusion of this service engagement, you will have DB2 Records Manager integrated with DB2 Content Manager for Multiplatform working in your test environment.

#### IBM Conversion Design and Planning Services for DB2 Records Manager

A three-phase methodology will be employed to convert your records management processes to IBM DB2 Records Manager. Phase I will consist of project planning, requirements gathering, and initial conversion design.
