Maximo SaaS Offering Landscape

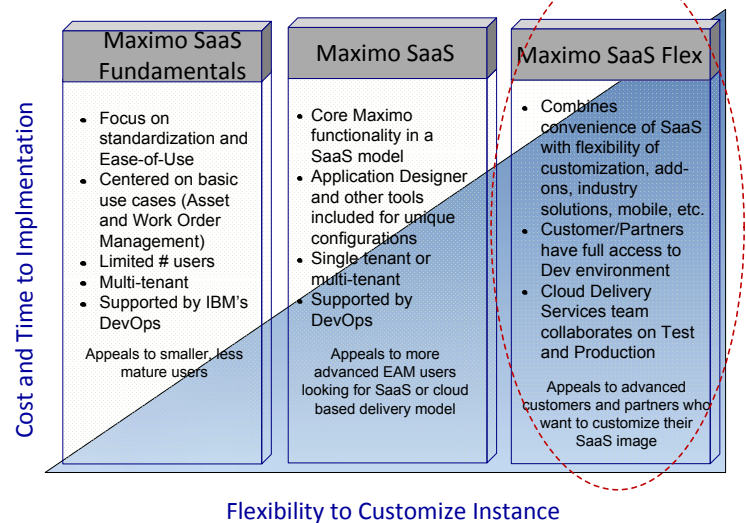


Figure 1: Maximo SaaS Offering Landscape.
