

CDS06 Integration and Connectivity

Highlights

Our Integration and Connectivity service offering is a best practice review to ensure that your CICS TS and CICS Tools Family of products are configured with optimal integration, both within the CICS Family and together with external products such as WebSphere Application Server and WebSphere MQ.

We check CICS-related configuration parameters and values and provide a report recommending any improvements that are necessary to meet best practice standards.

Depending upon your requirements, the Integration and Connectivity service offering ranges from a high-level conceptual engagement to an in depth study where we work with you to identify the key areas where change is recommended.

The Integration and Connectivity service offering is divided into three main areas.

Discovery

In this phase we will work with you to examine the integration and connectivity configuration of your existing environment, this will include CICS Family products such as CICS TS, CICS Transaction Gateway and CICS Tools and their integration with DB2, IMS, WebSphere MQ and WebSphere Application Server.

Analysis

In this phase we compare your configuration values with our knowledge of best practise parameters and settings and produce a report recommending changes to be made. One improvement area we typically find is the opportunity to reduce the number of network protocols in use. Other areas where we often make recommendations are:

- The use of CICS
 Transaction Gateway and
 Web services to connect to
 and obtain core business
 data from CICS
- Connecting CICS to WebSphere Application Server and/or WebSphere MQ
- Configuring for High Availability, for example elimination of single points of failure or the exploitation of WebSphere MQ queue sharing groups
- Configuring end to end security, such as asserting

- credentials from WAS to CICS over an SSL connection
- IP migration (DTP, TR, SNA to EE, TCP62 to EE, ECI/IP to IPIC). We can assist with using the APPC/MRO CICS migration utility to reduce the number of protocols in use in your environment
