- IZ09920: "Filter for scheduled time" is displayed as 01:mm:ss, if the JSC machine time is on 00:mm:ss.
- IZ09933: JSC fails to start using other's preference.xml, it the file contains DBCS strings.
- **IZ10774:** Filters on job streams in the plan.

- IZ11260: Backup master unable to access Tivoli Workload Scheduler database
- **IZ13009:** The job views in the plan tree have incorrect column headings, they have the job stream headings.
- IZ13165: "Column filter" for data in "hh:mm" format does not work.
- IZ13833: Valid from date displays incorrectly in jobstream view.
- IZ14931: "RELEASE SCHED" and "PROMPT" are logged to the plan audit log incorrectly.
- IZ14976: JSC 8.3 in the "explorer" the field "description" is empty.
- IZ15056: JSC 8.4 refresh is not refreshing the views
- **IY94109:** JSCUG: tws z/os connector install documentation updated to be updated on how to specify local users in Windows.

#### List of defects fixed:

- 37177: JSC: dates shifted one day back every time you open a run cycle
- 37273: Cannot add external job dependency with job that has extended name.

## Known problems and workarounds

The following are software limitations and workarounds that affect Tivoli Workload Scheduler Job Scheduling Console version 8.4.0 Fix Pack 03. They include the known limitations listed in the Release Notes for version 8.4.0 and version 8.4.0 Fix Pack 01 and Fix Pack 02 if not fixed by this fix pack:

#### For installation:

- You must install the PK47309 WebSphere Application Server patches on the master domain manager, to connect a Job Scheduling Console 8.4 to a Tivoli Workload Scheduler master domain manager 8.3 Fix Pack 01. (37302)
  - This is a known problem caused by WebSphere Application Server patches.
- The window displaying the installation summary displays the wrong disk space size.
- During the installation process a warning message might be displayed asking if you want to replace the Java<sup>™</sup> Virtual Machine. You must answer YES.
- Time zone bugs have been reported for Java 1.4.2 version 5 and later. 8.3.0-TIV-TWSJSC-FP0003 has been built using this level of Java to include the DST 2007 changes for U.S. and Canada.

#### At runtime:

- Problem with follows dependencies when repeat range used. (IY96400)
   If you create a job stream containing jobs for which you specified a Repeat Range and follows dependencies between jobs, the follows dependencies are not correctly displayed in the Job Stream Instance Editor.
- z/OS engines not migrated correctly if default queries are not used. When you migrate from feature levels 1.3 or 1.4, the z/OS® engines are migrated as distributed if in the previous version the default names for the queries had been left unchanged and no queries had been created. In this case you must create the z/OS engines again.

#### Estimated duration filter

In job and job stream plan lists you cannot filter the Estimated Duration by days (40428).

### Importing "All scheduled job instances"

Importing "All scheduled job instances" JSC 1.4 filters in JSC 8.4, the values of "Actual Start Time Range" refer to an older date (40564).

### Internationalization notes

The following are software limitations and workarounds that affect the international versions of Tivoli Workload Scheduler Job Scheduling Console version 8.4.0 Fix Pack 03, they include the known limitations listed in the Release Notes for version 8.4.0 and in the Tivoli Workload Scheduler Job Scheduling Console version 8.4.0 Fix Pack 01 and Fix Pack 02, if not fixed by this fix pack:

### Installing the Job Scheduling Console

The following are software limitations that affect the installation of the international versions of IBM Tivoli Workload Scheduler Job Scheduling Console:

### Patches required on HP-UX to view InstallShield dialogs

On HP-UX version 11iV1, the following patches are required to be able to correctly view the InstallShield installation dialogs in the related DBCS locales:

- PHSS\_26971 Japanese TrueType fonts
- PHSS\_26973 Korean TrueType fonts
- PHSS\_26975 Chinese-S TrueType fonts
- PHSS\_26977 Chinese-T TrueType fonts
- PHSS\_31988 X Font Server Patch

The zh\_CN.utf8 and zh\_TW.utf8 locales are not supported for this product by the InstallShield installation method.

## Incorrect warning message when running InstallShieldLanguage Pack installation on HP-UX

When you launch the Language Pack InstallShield installation wizard on HP-UX, you might get the following message:

Warning! One or more of your selected locales are not available. Please invoke the commands "locale" and "locale -a" to verify your selections and the available locales. Continuing processing using the "C" locale.

This message appears because the language is set to en\_US by the InstallShield script launcher. However, it is the C locale that is installed on the system that is actually used. You should therefore ignore this message and continue with the process.

## Language pack cannot be installed on IBM AIX® version 5.2 if path includes national characters

On IBM AIX version 5.2, installing the Job Scheduling Console in a path that includes national characters prevents installation of the language pack.

This is due to a problem in the InstallShield wizard. PMR OLAA6KWLG6 is now awaiting resolution by InstallShield.

As a temporary workaround, do not use national characters in the installation path for the Job Scheduling Console.

## Language Selection Panel displayed in English when running Language Pack uninstallation on IBM AIX

When you launch the Job Scheduling Console or the Language Pack uninstallation wizard on IBM AIX systems, the Language Selection Panel is displayed in English and not in the locale of the operating system. The panels that follow are, however, displayed in the locale that you select.

This is due to a problem in the InstallShield wizard. PMR OLAA6L6GVU is now awaiting resolution by InstallShield.

### BIDI characters are not supported by the interactive InstallShield wizard

As a workaround, use the silent installation wizard or a supported language in the interactive wizard.

## National characters corrupted in title of French InstallShield wizard on Red Hat $Linux^{\oplus}$

On the French version of Red Hat Linux, version 3.0, national characters are corrupted in the title of the interactive InstallShield wizard.

As a workaround, use the silent installation wizard or a supported language in the interactive wizard.

## National characters corrupted when running the interactive InstallShield wizard using X-Windows

When running the interactive InstallShield wizard using X-Windows, national characters might not display correctly. The incorrect display of characters depends on the version, operating system, and locale of the X-Windows system you are using.

This problem does not prevent the wizard from working correctly.

## **Using the Job Scheduling Console**

The following are software problems that affect how you use the international version of IBM Tivoli Workload Scheduler Job Scheduling Console:

#### Mnemonics missing for Presentation Services labels (21981)

For the DBCS locales, several mnemonics are missing for the Presentation Services labels. This might cause accessibility problems.

## The internal links in the translated glossaries do not work properly. No workaround.

## Help panel for External Commands Pick List window not available in non-English locales.

The help panel for the External Commands Pick List window is not available in non-English locales.

As a workaround, copy the English version (file tws\_2017.htm) into the Help subdirectory of your language.

## Disk space requirements

Before starting the fix pack installation in undoable mode, make sure you have at least 200 MB of free space in the root/Administrator home directory for the installation backup.

## Installation options

The Job Scheduling Console fix pack installation is based on ISMP technology. You can install the fix pack only after you have installed the Job Scheduling Console. When you start the fix pack installation a welcome panel is displayed. If you click **Next**, a discovery action is launched, and a panel with the Job Scheduling Console instance and the discovered Job Scheduling Console directory is displayed.

### No JSC instance is installed (8.4 or previous instances) => error message.

No JSC instance is installed (8.3 or previous instances) => error message. If no instance is discovered an error message appears. This means that the Job Scheduling Console is not installed on the machine or the registry has a problem. Click **Next**, and exit from the installation panel.

#### No JSC 8.4 FP is installed => only APPLY action is possible.

If there are no previous fix packs applied to the Job Scheduling Console, then you can only select the **Apply** action. With this action the fix pack is installed in undoable mode and a backup copy of the product is stored on your workstation.

## Previous JSC 8.4 FP is installed => APPLY current FP or ROLLBACK or COMMIT previous FP are permitted

If there are previous fix packs already installed, **Apply**, **Rollback** and **Commit** actions are available. If you select **Apply** the new fix pack is installed. If you select **Rollback**, you remove the fix pack installation and return to the previous installation of the Job Scheduling Console. If you select **Commit**, the installation backup copy is deleted and the fix pack installation mode changes to commit. Use the commit action after you have tested the fix pack.

If the fix pack installation is in commit mode and is corrupt, you can run the setup program and select the **Repair** action. This action is displayed in the panel in place of the apply action.

If you have a Tivoli Workload Scheduler Job Scheduling Console fix pack installed in "undoable mode" (IU state) on your machine and you are applying a more recent Tivoli Workload Scheduler Job Scheduling Console fix pack on it, all the changes that you have made when installing the previous Tivoli Workload Scheduler Job Scheduling Console fix pack will be committed before applying the newer ones. Therefore, if you undo the fix pack you last installed, you will restore the previous fix pack changes.

## Installing using the ISMP wizard

Follow these steps to install the fix pack using the wizard:

1. Choose one of the following:

- Before installing the fix pack, create a backup copy of the Job Scheduling Console preferences file located inside the .twsconsole directory.
- Insert the CD for your operating system in the CD ROM drive. See "Fix pack structure in the installation CDs" on page 7.
- Navigate to the INSTALLER directory.
- Download the specific TAR or ZIP file for the operating system and unpack it. If you are installing on a UNIX® operating system, run the following command:

chmod -R 755 <imagesDir>

2. Depending on the type of operating system run:

#### On Windows®:

setup.exe

### On UNIX:

./setup.bin

- 3. Select the language of the installation wizard. Click **OK**.
- 4. Read the welcome information and click Next.
- 5. Read and accept the license agreement. Click Next.
- 6. The installation starts. When you are asked, select the instance of Tivoli Workload Scheduler Job Scheduling Console on which you are installing the fix pack.
- 7. Click **Finish** to complete the installation.

## Installing using the ISMP silent installation

The silent installation requires the customization of a response file. A sample response file is available on all CDs, in the Response\_File directory.

Run the following command from the path were the SETUP file is located to start the installation in silent mode:

• On Windows:

setup.exe -options JSCFixPackinstallation.txt -silent

On UNIX:

./setup.bin -options JSCFixPackinstallation.txt -silent

where JSCFixPackinstallation.txt is the name of the response file you customized with your environment settings.

Table 7 lists the keywords you can set in the -W beanActionsPanel.selectedAction parameter to custom the JSCFixPackinstallation.txt response file to your needs:

## Uninstalling the fix pack

You can uninstall the fix pack only if you installed it in undoable mode.

To uninstall the fix pack perform the following steps:

- 1. Launch the installation setup related to your operating system (from the installation CD or from the directory where you downloaded the tar file).
- 2. Select the instance you want to remove.
- 3. Select the UNDO option.
- 4. Click Finish.

-Duser.region=yy
