Chapter 1. Foreword

How to use this manual for system installation

If a previous version of Pactables is already installed on the site, the installation of the 3.5 version must be distinct from any former Pactables version regarding the installation parameters. The test case provided on the installation media must be executed.

The installation of this version does not require any retrieval.

Chapter 2. Pactables components

Introduction

The purpose of the Pactables function is to process a certain amount of permanent data whether on-line or in batch mode (see the Pactables Reference Manual).

Two types of resources are therefore necessary:

- Directories which store the programs making up the Pactables module, and its parameters.
- Permanent files, which contain the data processed by the Pactables module. These files can be divided into two categories:
 - ‘System’ files, which remain stable during the use of the Pactables function,
 - ‘Evolving’ files, which are handled by the users, and whose volumes vary according to the types of updates performed.

Note:

Pactables is installed independently of the other VisualAge Pacbase functions.

The implementation of the Pactables function requires data which must be defined and described with the VisualAge Pacbase Specifications Dictionary function. The Extraction Procedure required to operate the Pactables function is described in the VisualAge Pacbase 3.5 Operations Manual.

The macro-structures of TUF-TP facility

- The Macro-structures are the following ones:

Code	Meaning
AATUFA	Description of the table data element
AATUFL	‘LT’ or ‘LH’ list
AATUFS	‘LS’ or ‘LC’ list
AATUFU	List of user parameters
AATUFX	List of table items

These macro-structures are to be used in user on-line application programs using the TUF-TP facility.

They allow to add the description of communication areas which are necessary to call the BVPFT90 sub-program of the TUF-TP facility.

These Macro-structures are supplied as VA Pac update transactions. They can be downloaded through the VA Pac Support web page at <http://www.ibm.com/software/awdtools/vapacbase/support.html>

They must be loaded into the VA Pac library used for the development of user transactions by taking the transactions of VA Pac UPDP or UPDT procedures as input.

The system files

They represent the system itself. They are not subjected to daily handling and must be re-loaded if the system has to be re-installed. They are constituted of:

- Batch and on-line executable programs
(installed in the SYS/PGM directories)
- a file containing the error messages and the automatic documentation of the Pactables function : TE

The evolving files

They contain the user's data and are processed by the system, in either on-line or batch mode.

The first two make up the actual Pactables files:

The third file contains the user parameters, required for the system operations. It is managed by a specific batch procedure.

The TG file includes the user codes and the corresponding access authorizations.

User access facilities

Some sub-programs enable user applications to access Pactables:

These programs, supplied with a '.DLL' extension and compiled in the Pactables Windows/NT environment, can be executed with the same Micro Focus Run-Time.

They are supplied in the \$TABDIR/SYS/PGM directory.

These sub-programs can be used in Batch or on-line user applications.

Chapter 3. Installation

Prerequisites

Hardware and software

- Architecture: a Windows/NT, Windows 2000, Windows XP or Windows 2003 server.
- Processor: workstation with Windows NT server (4.0 minimum), Windows 2000, Windows XP or Windows 2003.
- Memory: 96 Mb. Additional memory may be needed depending on the number of servers installed on the same machine.
- Software:
 - Microsoft Windows Script, version 5.1 onwards. You can download it from the following URL:
www.microsoft.com/downloads
- For the MICROFOCUS version:
MICRO FOCUS Application Server
- For the Acucorp version:
ACUCOBOL-GT

CAUTION:

Besides installing the cobol runtime, you must update the system environment variables (PATH, COBPATH...).

For AcuCobol, the PATH system variable must be completed with the path of the AcuCobol runtime (usually ..\AcuGT\bin). The machine must then be rebooted.

- Installation medium : CD-ROM drive.

Disk space

The disk space used by the files depends on the size of the applications managed by the system.

The disk space required for the servers installation is around 6.5 millions of bytes.

Installation

Introduction

The product is supplied on a CD-Rom.

To perform the installation, you must be connected with NT Administrator's authorizations.

By default, the Server is installed on

C:\Program Files\IBM\VisualAge Pacbase\

However you will be able to modify the unit and directory name during the installation process.

The installation is performed in the \Pactables directory and includes two successive steps:

1. installation of the System, which creates the \SYS\ directory
2. installation of the Pactables database, which creates the \CONFIG\[database_name]\ and the \DATA\[database_name]\ subdirectories.

Each step can be executed independently or not, but always in this order.

All the Databases are created with the installation test data and configuration parameters.

CAUTION:

In this manual, [database_name] used in the directory full name corresponds to the name of the directory concerning the database for the server data. It does not correspond to the database code.

System installation

The execution of setup.exe opens a graphical interface which guides you through the installation process.

After a Welcome screen, it displays some workstation characteristics which can be modified:

- Owner's Name and Organization
- Location for the installation (C:\Program Files\IBM\VisualAge Pacbase\ by default)

The installation copies:

- the translation file, the labels file produce by the procedures in case of error or for information,
- the programs,
- the procedures,

- the Database creation utility,
- the startup script models,
- the error messages file.

Repository installation

Pactables database

You can install a Pactables database directly after the system installation, or independently via the 'Start' menu by selecting the [Create New Database] shortcut in the [VisualAge Pacbase 3.5 Pactables Server] group.

To install a Development database, you must specify the following elements:

- the Database name (8 char.),
- the Database code (4 char.),
- the Database port number (between 49152 and 65535, unique for each Database),
- the Database language code (English by default).

More than one Development Database can be installed. each has its own environment.

You can modify the proposed directories (by default: C:\Program Files\IBM\VisualAge Pacbase\).

Therefore, you can modify the backup directory, the temporary files directory, or the user directory which notably contains the procedures execution reports.

Configuration parameters

For each Database, a Configuration directory is created with:

1- BvpServer.ini, containing the parameters of the conversational server,

Unreference a database

The BVPDELDB procedure is used to unreference a Database on a Windows platform.

This procedure executes the following operations:

- deletion of the Windows service for a given database,
- deletion of configuration information (CONFIG directory),
- deletion of information specific to the Database in the Windows Registry,

- deletion of shortcuts for the Database,
- renaming of the Database data directories.

Connection

Server start-up and stop

The Listener must be installed in NT Service mode.

Terminals can then connect to Pactables.

Via the 'Start [Database_name] Database Service' shortcut located in the [VisualAge Pacbase 3.5 Pactables Server] programs group of the Start menu, you can start the listener on the [Database_name] Database.

Via the 'Stop [Database_name] Database Service' shortcut located in the [VisualAge Pacbase 3.5 Pactables Server] programs group of the Start menu, you can stop the listener on the [Database_name] Database.

The listener processing parameters are defined in the "Server.wsf" procedure.

When abnormal executions occur in a listener, messages can be displayed in the list of events of the 'Event Viewer' administration tool, under 'Log/Application'.

These 'ERROR'-category events can give a first indication. They generally correspond to problems in the execution environment.

However, in case of abnormal processing, the product support may ask you to activate the 'trace mode' to detect the source of the error.

- TRACE MODE

Different trace levels can be implemented:

- Level 1
Minimum trace allowing to follow the listener processing with the calls to the COBOL communication monitor,
- Level 2
Detailed trace of the listener processing,
- Level 4
Trace of the messages between the listener and the client workstation.

In the listener startup procedure, 'server.wsf', the purpose of the SRV_TRACE environment variable is to activate the trace mode. To use another trace level, you must set the SRV_TRACE variable and re-start the listener.

EXAMPLE:

SRV_TRACE=1 for a trace level 1

SRV_TRACE=3 for a trace level 1 and 2

SRV_TRACE=5 for a trace level 1 and 4

There are two types of trace result files:

- srv[process_number].txt

to trace the listener (BvpServer.exe).

- dial[process_number].txt

to trace each listener connection (BvpDial.exe).

These files are located in the SRV_DIR directory, set by default in server.wsf file to:

.../data/[database_name]/tmp

The SRV_TRACE_DEL environment variable is set to keep all or a part of the traces created by the listener execution in "dialnnn.txt" :

SRV_TRACE_DEL : "ON" (default value)

to keep traces produced by a processing error only.

SRV_TRACE_DEL : "OFF"

to keep all the traces.

3270 emulator start-up

You can access an on-line server, in character mode, via a 3270 emulator.

To access a database in a 3270 mode via an on-line server, you must configure the emulator by indicating:

- the IP address of the machine where the on-line server is implemented,
- the on-line server listening port number, chosen upon installation when the Database is created.

The code page of the emulator must be valorized according to the database language code:

- code page 1147 for a French Database,
- code page 1146 for an English Database.

These code pages are automatically set in the 'Server.wsf' procedure when the online server is started up.

Transaction code of the user parameters: 'TABPARM'.

Transaction code for the access to the Pactables function: 'PACTABLES'.

Use tests

These test jobs include the following steps:

- On-line use tests,
- Test on batch updating, printing and reorganization,
- Test on table generation.

The test set comprises three tables:

- 'TEMPER' without historical account,
- 'CUSTOM' with two historical accounts 01/03/1985 and 15/01/1985,
- 'ARTICL' with historical account 15/01/1987.

Tests on the user parameters transaction:

- Submit the Paclink Administrator transaction. The user code defined in the test Database is the manager's: user code '*****' and password 'SUPER'.
- Use this code to enter the transaction and define other users, then modify the Database manager's user code password.

On-line tests:

- Start up an on-line server; connect it to the workstation.
- Consult all the screens.
- Execute the updates.

Batch tests:

- Execute the PRTA procedure.
- Execute the EXTA procedure.
- Close the on-line server.
- Execute the UPTA procedure.
- Reorganization of the test table:
 - Save TV and TD files (COPY under different names).
 - Execute the reorganization (RETA) which comprises:
 - Reorganization of TV file (Prog. BVPTA400 and BVPTA410),
 - Reorganization of TD file (Prog. BVPTA420),
 - Constitution of the TC backup file (Prog. BVPTA430),
 - Restore the TV and TD files (RSTA),

- Execute a printing (PRTA) for verification.
- Start up the on-line server and a workstation.
- Do some verification tests after reorganization.

Table generation tests (GETT procedure) :

- Close the station and the on-line server.
- Execute an extraction procedure (GETA or GETD).
- Execute the GETT procedure.
- Verify the execution.
- Start up the on-line server and a workstation.
- Do some verification tests.

Chapter 4. Re-installation/removing of components

Introduction

The system environment of the Pactables server must be re-installed whenever enhancements to the currently installed version are being delivered.

Generally, system files (error messages, generation skeletons, ...) and programs only are impacted by a new subversion.

Procedure start-up

The Pactables Installation CD-Rom also allows you to:

- "Update" an already installed Pactables module.
- "Remove" an already installed Pactables module.

You can also use the Windows service 'Add/Remove' Programs in the Configuration Panel.

Chapter 5. The batch procedures

Introduction

The Batch processes associated with Pactables are grouped in procedures. The next chapters present each of these procedures and specify their execution conditions.

For each procedure there is:

- An introduction comprising:
 - the procedure's functionality,
 - the execution conditions,
 - the actions to carry out in case of abnormal execution.
- The description of the user input, processes, and results obtained, as well as advice on use.
- Description of steps:
 - the notations or parameters in use,
 - the list of files in use (temporary and permanent),
 - the return codes for each step.

Classification of procedures

The following procedures are associated with batch processes:

- INTA: Initialization of Pactables files,
- GETT: Table generation,
- UPTA: Table update,
- PRTA: Table printing,
- IMTA: Table import,
- RETA: Table reorganization,
- SVTA: Table backup,
- RSTA: Table restoration,
- LDTA: List of tables descriptions,
- PMTA: User parameters update,
- EXTA: Table extraction,
- TUTA: Table production turnover.

For the Dispatched Table Management (DTM option):

- Table description comparison (CDT1, CDT2),

- Table contents update (CVTA).

For converting from another platform:

- Pactables Database migration (TCTA).

Reminder

Pactables does not include a journal of update transactions.

Abnormal executions

Abends may occur during the execution of a batch program. Input-output errors on the system files or on the Database cause a forced abnormal end with a return code '12', described by a message on the .Log file of the procedure.

When an abend occurs, you must find the error message. This message is displayed in the following manner:

```
PROGR : pppppp INPUT-OUTPUT ERROR : FILE ff OP : oo
STATUS : ss
END OF RUN DUE TO PROVOKED ABEND
```

This message appears by setting, previously, the "NoDisp" variable to "NO" in Intb.vbs.

In most cases, examining the status and type enables you to find the cause of the abnormal execution.

The summary table below lists the most common values for status and type of operation.

Code	Operation
W	WRITE
RW	REWRITE

Status	Message

When this message is absent, and the type of ABEND generated directly reports a problem in the product system programs, contact the VisualAge Pacbase support at IBM. KEEP ALL LISTINGS that may be necessary to analyze the problem.

If the error is not an input-output error on a Database file, the following message is displayed:

Run Time Error nnn

where nnn is the error number.

The Run Time Error 013 is the most frequent. It indicates that the procedure did not find an input file.

The next subchapter contains the list of the most frequent errors. Each Run Time Error is briefly described.

If the Run Time Error is not in the following list or if its associated description is not explicit enough and if the error directly involves the system programs, you must contact the Hot Line and keep all listings which might be useful in solving the problem.

Management of errors in the procedures

If an error is detected in a step, the next steps are not executed. The name of the erroneous program and, if possible, the type of the detected error, are displayed.

The procedure then displays the message:

"Press Return to carry on"

You must then stop the procedure, in order to view the error if several procedures follow one another.

(If the NOBVPERR environment variable is set to 'yes', this message is not displayed and you do not have to stop the procedure)

The procedure stops with a return code other than zero. This code can be retrieved via the Return variable right after the command which submits the procedure. This prevents the execution of the next procedures if various procedures are executed in sequence.

Procedure definition

A procedure is a Windows Scripting script (.wsf), which includes Visual Basic Script scripts (.vbs).

Each procedure can be executed only via a launch Script (.wsf) which contains the following information:

- a <resource id> field constituted of input data (141 lines maximum) or the definition of an input file by WshEnv("BVP_Input") = "full file name" (the priority value),
- the user code,
- the Database external name (directory under \DATA),
- the complete assignments of the configurable files of the procedure, example : WshEnv("PTA310_PAC7NK") = "External table file".

You must enter all this information before launching the procedure.

Other elements can also be specified to assign files or parameterize procedures (e.g. whether the message must be displayed or written in a file).

In any case, the provided user inputs must be verified and adapted to your environment (<resource id> or BVP_Input).

Temporary files, execution reports and output files are found under directories created dynamically.

- Temporary files are located under: \DATA\[Database_name]\TMP\[user_code]\[proc_name]-[number]

They are deleted at the end of the procedure execution. If you do not want these files to be deleted, you must previously set the "DelDo" variable to "NO" in Intb.vbs. So you will have to delete them manually.

Once this variable is set up ("NO" or "YES"), it is valid for ALL the procedures.

- Output files, execution reports are located under: \DATA\[Database_name]\USERS\[user_code]\[proc_name]-[number]

This number is an application execution number ; by default it is the process number of the procedure.

WARNING:

In Pactables for Acucorp, when a procedure containing a Cobol sort is abnormally executing, the temporary sort files may not be automatically deleted. These 16 files, which name begins by "T" are located in the Windows temporary directory (\TMP or \TEMP) or directly under "C:\". There date and time correspond to the procedure launch time.

Procedure launch

You can execute the launch script (BVPproc.wsf) or the supervisor (Prbvp.vbs):

- via a command line,
- by double-clicking on them,
- via the 'Start' menu: Access the '[Database_name] Database Utilities' shortcut in the 'VisualAge Pacbase 3.5 Pactables Server' group of [Database_name] and enter [Script_name].

NB: The Prbvp.vbs supervisor is an independent VBScript procedure which starts the execution of the launch scripts. It requires 2 arguments: [Database_name] [script_name] ; [Database_name] is located under directory \DATA.

To be executed, each procedure requires the definition of various elements:

1. either in the launch script: This launch script, BVPxxxx.wsf, is in Windows Scripting.
 - a. user code
 - b. Database external name (directory under \DATA)
 - c. The input data is described in the <resource id> field of the script and retrieved in the BVP_Resource environment variable (in this case, the data volume is limited to 141 lines), or can also be contained in a file named in the BVP_Input environment variable (in this case, the data volume is not limited).

2. or in the part which is common to all procedures. This common part, named 'INIT.vbs', is a VBScript inclusion, in each procedure.

 - b. Assignment of 2 parameters with 2 possible values:

IMTA - Table import

IMTA - Introduction

This procedure imports external tables into the existing Pactables files.

You must first enter the description of the Table you want to import into the VA Pac Database, then generate this description (GETA/GETT procedures).

Once you have performed these operations, you can import the external table via the IMTA procedure.

The IMTA input format of the Table to be imported is a sequential file which contains one record per table item, whose contents corresponds to the description entered in the VA Pac Database (input format).

The length of this file record is 999 characters (maximum length of a table item).

Execution condition

Since this procedure updates the TV Table file, the files must be closed to on-line use except for equipment allowing batch/TP concurrence.

NOTE for platforms where the disk space allocated to the files is fixed:

If the table to be imported is large, it may be necessary, before executing this procedure, to save and reload in order to increase the size of the TV file or physically reorganize this file so as to make all the initially provided free space available.

Restriction

The procedure allows you to import only one table per execution.

Important note

An alternative version of the update program, BVPTA312, is shipped with Pactables V2.0 onwards.

During updates, the BVPTA310 program may call user control routines in order to perform additional controls. The default generation option for these routines is 'without century management'.

With the V2.0 onwards, if the user control routines are generated with the century-management option, the new program, BVPTA312, must therefore be renamed and used instead of the BVPTA310 program.

In all cases, ALL the user control routines should be generated with the same century-management option.

RETA - Table reorganization

RETA - Introduction

From the Pactables Database, this procedure rebuilds the backup file which contains the new tables' description and content files; these files are the reorganized images of the initial TD and TV files.

RETA deletes the records that were logically deleted during update by reorganizing the historical accounts of the files according to the user's requests (see the Pactables Reference Manual). The records that were logically deleted can be kept via an option.

For user programs written in Cobol II, RETA assigns a sign + to positive signed numeric data (not available in previous releases).

Execution condition

To ensure the consistency of the reorganized database, files must be closed to on-line use.

TCTA - Pactables transfer from another platform

TCTA - Introduction

The purpose of this procedure is to retrieve Pactables Databases from other platforms (source platforms) in order to adapt them to your environment.

The Database backup is sorted according to the format of the target platform (ASCII or EBCDIC).

If the version of the source site is the same as that of the target site, the actions to be performed are the following ones:

- Backup on the source site (SVTA procedure)
- Transfer of the TC file produced by SVTA to the target platform,
- Retrieval of the file on the target platform (TCTA procedure),
- Restoration of the database (RSTA procedure), using as input the TC file built by the preceding step.

If, on the contrary, the source site is of an older version, and that the version requires a retrieval, the TC backup must be retrieved in the new format ON THE SOURCE SITE before being transferred onto the target environment.

Execution condition

None. But carefully read the note below.

Note:

1. Backup transfer

The transfer of the TC backup from the original site to the local network where Pactables is to be installed, is handled by the user. The parameters to be specified during the transfer are: the data files (DATA), which must be converted to the ASCII format and must contain the control characters for the recordings ends (CRLF in general, or LINE_FEED).

2. Disk space

The TCTA procedure, described below, consists in sorting the TC backup according to an ASCII sequence. The sort is carried out in 3 different programs to minimize the required disk space. However, the procedure needs 3 to 4 times the equivalent of the original file.

This procedure does not include the deletion of the TC.INI file. It is possible to delete this file at the end of the first step, if the user needs more disk space.

For execution reasons, it is recommended to create the work and sort files on the Pactables server disk which executes the programs.
