Since its passage in 1996, the Health Insurance Portability and Accountability Act (HIPAA) has become a primary focus of the healthcare industry—involving providers, payers and clearinghouses. HIPAA mandates a three-part foundation for national health information processing: uniform standards for electronic transactions, security of transmitted data and individual privacy rights. Current projections indicate that electronic data interchange (EDI) will reduce the estimated 17 to 20 percent of healthcare costs attributed to administration and overhead. But with electronic transmission of healthcare data comes anxiety over the privacy of this critical data. As a result, HIPAA has also mandated security and privacy standards to protect the confidentiality of personal health information.

- *The widespread use of EDI in healthcare*
- *The elimination of costly paper processing, multiple forms and formats*
- *A greater focus on delivering cost-effective, high-quality healthcare*
- *Protection of confidential, patient-identifiable health information*
- *Protection of electronic information flow among employers, health plans, providers and patients*

The HIPAA challenge

HIPAA is effecting major changes among the disparate health insurance provider and payer networks. Even government agencies—many of them acting as healthcare providers and payers—are not immune from HIPAA. HIPAA has challenged your organization to transform how you conduct e-commerce.
