Data Migrations


A data migration is the process of moving data from one iSeries^(TM) server that is running OS/400^(R) V5R1, V5R2, or V5R3 to another iSeries server running V5R3. This information does not describe how to migrate your data from an OS/400 release earlier than V5R1.

For information about migrating data to another  server platform, see the  Data migration topic.

A License Addendum will be provided to allow customers to install and use the copy of OS/400 (received with the newly ordered server) on their source server for up to 70 days. This Addendum authorizes the customers to use the new version and release on the source system for the sole purpose of migrating their data. The previous version and release must be reinstalled after the migration is completed. The V5R1 license of OS/400 and the licensed programs will only allow the product to be run on one system at a time. Feature Code #0205 provides for minimal pre-loading of the new server, and includes a special License Addendum.

This information assumes that you are moving data from one server to another. If you are installing a new version of OS/400 on the same server, it is not necessary to perform an explicit data migration. You can use the Install, upgrade, or delete OS/400 and related software topic. If you are upgrading to a new iSeries server without changing the serial number, use the Upgrades topic. If you are migrating data from one iSeries server partition to another partition on the same server, follow the instructions in Chapter 4. "Restoring a Logical Partition to Another Logical Partition—Checklist 22" of the Backup and Recovery

Guide  .

Migration concepts

A data migration is the process of moving data from one iSeries^(TM) server to a new iSeries server where the source server and the target server have different serial numbers. To become familiar with the terminology used in this topic, see “Migration terminology.”

Data migration process

The data migration process includes planning, ordering, preparing for, and performing the data migration. Planning is most involved and may require up to six weeks, depending on the complexity of your environment. Installing the OS/400^(R) release on the source server requires at least one hour. Migrating the data from the source server to the target server can normally be accomplished in up to three days.

Migration terminology

A migration is the process of moving data or software from one iSeries^(TM) server to another iSeries server. Review this information to become familiar with the terminology used to describe migrations. If you are moving from one iSeries server, hardware feature, or software version to another iSeries server, hardware feature or software version and retaining the same server serial number, see Upgrade terminology.

migration

Any movement of software or data. When used in this topic, migration refers to any of the following:

- Movement of software or data where the data is used on a different server (with a different server serial number)
- Movement of software or data that skips one or more releases of the software
- A situation where one software feature is converted to another software feature

Contrast migration with upgrade, where the target server retains the serial number of the source server.

data migration

The movement of data when the software is upgraded or the data is transferred to a different hardware server or model.


source server

The existing server that is being migrated to a new level of software.

target server

The planned hardware configuration and software level which will exist when the migration is completed.

Plan the migration

The time you spend planning for your data migration can help minimize your downtime and make performing the migration easier. You can view planning tasks or create a customized planning checklist using the information available in the Planning topic of the  Information Center. To use this information, you need to know specific information about your order, such as model release, features, and any additional solutions you have ordered. Return to this topic when you have completed the planning tasks in the checklist for your environment.

Before you can migrate your data, you must do the following:

Plan for the hardware, which includes the following:

- Ordering the target server with feature code 0205.
This feature code ensures that the target server is set up for the data migration and entitles you to run the new operating system on both the source and target servers for a maximum of 70 days so that you can complete the data migration. You must reinstall the previous operating system on the source server after the data migration is complete.
- Identifying disk storage requirements.
You must ensure that you have enough disk storage capacity for the new operating system and for the data from the source server, as well as for any new data and software planned for the target server.
- Identifying any tape incompatibilities.
You must ensure that you have a tape drive that is compatible with the target server.

To determine if your tape drive is compatible, see the Storage Solutions Web site  or the iSeries^(TM)

Handbook . To learn more about tape devices, see the Tape topic.

- Ensuring that you have a physical plan for the target server.
The target server is going to be set up and running beside the source server for a period of time. There are physical planning and setup implications that pertain to the target server.

Plan for the software, which includes the following:

- Evaluating disk storage space requirements.
You must ensure that you will have adequate disk storage before you start to install or replace software.
- Identifying possible upgrade paths for licensed programs.
When you install the new release of OS/400^(R), some licensed programs may no longer work. You should identify licensed programs that are no longer available at this release and their replacements where applicable. Additionally, to avoid losing data that depends on these licensed programs, migrate the data from your server to an accessible location before installing the new release of OS/400.

Plan for your connection, which includes the following:


- Choosing a console.
If you are using a twinaxial console on the source server and using Operations Console on the target server, ensure that you have a twinaxial controller for any twinaxial devices you plan to run from the target server.

When you have completed these tasks, you should have a final data migration plan that includes the following:

Perform the migration

This topic describes how to migrate data from one server to another. Before you begin these tasks, be sure you have completed the necessary “Plan the migration” on page 6. You can migrate your data by using one of these paths:

If you can load OS/400^(R) V5R3 on your source server, perform the following tasks:

1. “Prepare for the migration.”
2. “Complete the migration” on page 8.

If you cannot load OS/400 V5R3 on your source server, perform the following tasks:

1. “Prepare for the migration from a 4xx or 5xx server” on page 9.
2. “Complete the migration from a 4xx or 5xx server” on page 10.


Prepare for the migration

This topic describes how to prepare to migrate your data to a new target server. Before you begin this procedure, be sure you have completed these prerequisite tasks:


- Obtain and review the preventive service planning (PSP) information.
The PSP document for V5R3 data migrations is SF98167. Review this document for the most current information about conditions that might affect your data migration.
- “Plan the migration” on page 6.

Then, to prepare to migrate your data, perform these tasks:

Prepare target server

1. Ensure that your console is set up and ready.
Note: If you are using a twinaxial console on the source server and using Operations Console on the target server, ensure that you have a twinaxial controller for any twinaxial devices you plan to run from the target server.
2. Verify that the target server is set up and is running with only the Licensed Internal Code and the operating system (OS/400^(R)) installed (feature code 0205).
3. If you are configuring a server with logical partitions, you must create logical partitions on the target server and then install the Licensed Internal Code and OS/400 on each secondary partition. Allow at least two additional hours to do this for each partition.
4. Perform disk unit management (for example, manage disk protection and disk configuration).
To do this, you can use the Work with Disk Units option from the Dedicated Service Tools display. For more information, see the chapter that contains Procedures for configuring disks and disk protection in the Backup and Recovery Guide .

Prepare source server

1. Prepare to install the OS/400 release.
Ensure that you do the following:
 - Use the Work with Line Descriptions command (WRKLIND) to view and delete unused lines and line descriptions.
 - Use the Work with Device Descriptions command (WRKDEVD) to delete unused device descriptions.
Note: You can use the Work with Line Descriptions and Work with Device Descriptions commands to view and verify that all of the descriptions listed are in use. If you are sure one is not in use, delete it. If you are not sure, you should leave it.
 - Save the entire server so you can restore it to its original state after performing the data migration.
Note: It is recommended that you have two copies of the backup media.
Feature code 0205 entitles you to run the new operating system on both the source and target servers for a maximum of 70 days so that you can complete the data migration. When the data migration is complete, you must reinstall the previous operating system on the source server to restore the server to its original state. To restore the server to its original state, follow the steps in Recovering your server in Appendix D of the Backup and Recovery Guide . Use the Backup and Recovery Guide for the release that you want to restore.
2. Complete the installation of the OS/400 release.
3. Print your server configuration information as follows:
 - a. On the OS/400 command line, enter PRSYSINF and then print the resulting spooled file.
This prints reports of the hardware resources, software resources, system values, installed fixes (program temporary fixes or PTFs), and other configuration information.
 - b. Print a new system configuration list and keep this list for future reference.
 - c. On the OS/400 command line, enter WRKDEVD. Use option 6 (Print) to print the device descriptions.
 - d. On the OS/400 command line, enter WRKCTLD. Use option 6 (Print) to print the controller descriptions.
 - e. If you have a partitioned server, print the system configuration for logical partitions.

Stabilize the source server

1. Run the source server at the new release level for 2 weeks.
2. Save the entire server using option 21 of the GO SAVE command. Make sure that you specify the following options:
 - a. Vary off the network server...*ALL
 - b. Unmount file systems.....Y

Note: It is recommended that you have two copies of the backup media.

The next step is to “Complete the migration.”

Complete the migration

Before you begin these tasks, be sure you have completed the necessary “Prepare for the migration” on page 7. Then to migrate data to the target server or partition, perform these tasks:

1. Perform the steps in Appendix E: “Recovering your server to a different server” of the Backup and Recovery Guide



If a controller or device no longer has a valid resource on the system, follow the steps in fix hardware resource names after an upgrade to make the necessary corrections.

2. Install any new licensed programs (LPs).


3. Print your server configuration information as follows:
 - a. On the OS/400^(R) command line, enter PRTSYSINF and then print the resulting spooled file. This prints reports of the hardware resources, software resources, system values, installed fixes (program temporary fixes or PTFs), and other configuration information.
 - b. Print a new system configuration list and keep this list for future reference.
 - c. On the OS/400 command line, enter WRKDEVD. Use option 6 to print the device descriptions.
 - d. On the OS/400 command line, enter WRKCTLD. Use option 6 to print the controller descriptions.
 - e. If you have a partitioned server, print the system configuration for logical partition.
4. Save the entire server using option 21 of the GO SAVE command. Make sure that you specify the following options:
 - a. Vary off the network server...*ALL
 - b. Unmount file systems.....Y

Note: It is recommended that you have two copies of the backup media.
5. Resume normal operations and verify that all your applications run properly.
6. Tune the server performance.

This ensures that your servers make the best use of the system resources, and allows workloads to run as efficiently as possible.

Prepare for the migration from a 4xx or 5xx server

If you cannot install V5R3 of OS/400^(R) on your source iSeries^(TM) server, you can still migrate your data by saving your source server and then performing a full server recovery onto the target server. This topic describes how to prepare to migrate your data from a 4xx or 5xx server to the new target server. Before you begin this procedure, be sure you have completed these prerequisite tasks:

- Obtain and review the preventive service planning (PSP) information. The PSP document for V5R3 data migrations is SF98167. Review this document for the most current information about conditions that can affect your data migration.
- “Plan the migration” on page 6.
- Review the introductory information about Previous Release-to-Current Release Support in the Backup and Recovery Guide .

Then, to prepare to migrate your data from a 4xx or 5xx server, perform these tasks:

Prepare target server

1. Verify that the target server is set up and is running with only the Licensed Internal Code and the operating system (OS/400) installed (feature code 0205).
2. If you are configuring a server with logical partitions, you must create logical partitions on the target server and then install the Licensed Internal Code and OS/400 on each secondary partition. Allow at least two additional hours to do this for each partition.
3. Ensure that your console is set up and ready.

Note: If you are using a twinaxial console on the source server and using Operations Console on the target server, ensure that you have a twinaxial controller for any twinaxial devices you plan to run from the target server.
4. Perform disk unit management (for example, manage disk protection and disk configuration). To do this, you can use the Work with Disk Units option from the Dedicated Service Tools display. For information, see the chapter that contains Procedures for configuring disks and disk protection in the Backup and Recovery Guide



5. Make sure that you have a copy of the distribution media for the target server.

Prepare source server

1. Clean up the source server as follows:
 - a. Use the Work with Line Descriptions command (WRKLIND) to view and delete unused lines and line descriptions.
 - b. Use the Work with Device Descriptions command (WRKDEVD) to delete unused device descriptions.
Note: You can use the Work with Line Descriptions and Work with Device Descriptions commands to view and verify that all of the descriptions listed are in use. If you are sure one is not in use, delete it. If you are not sure, you should leave it.
 - c. Clean up disk storage space.
2. Ensure you have required fixes (program temporary fixes or PTFs).
3. Collect performance data.
This gives you a basis for comparing performance before and after the data migration.
4. On the OS/400 command line, enter RTVSYSDINF.
When you run this command, you will need to specify the library to use. Typically, you should specify the QUPGRADE library. If this library does not exist, create it with the Create Library (CRTLIB) command.
5. Print your server configuration information as follows:
 - a. On the OS/400 command line, enter PRTSYSINF and then print the resulting spooled file.
This prints reports of the hardware resources, software resources, system values, installed fixes (program temporary fixes or PTFs), and other configuration information.
 - b. Print a new system configuration list and keep this list for future reference.
 - c. On the OS/400 command line, enter WRKDEVD. Use option 6 (Print) to print the device descriptions.
 - d. On the OS/400 command line, enter WRKCTLD. Use option 6 (Print) to print the controller descriptions.
 - e. If you have relational database directories, on the OS/400 command line enter DSPRDBDIRE *ALL OUTPUT(*PRINT)" to print the entries.
 - f. If you have a partitioned server, print the system configuration for logical partitions.
 - g. If necessary, save spooled files.
For more information, see Save spooled files in the Information Center.
 - h. Job scheduler entries will not be restored on the target server. Use the print option on the Work with Job Scheduler Entries (WRKJOBSCDE) command to record your current job scheduler entries so you can manually re-create them on the target server.
6. Save the entire server using option 21 of the GO SAVE command. Make sure that you specify the following options:
 - a. Vary off the network server...*ALL
 - b. Unmount file systems.....Y
Note: It is recommended that you have two copies of the backup media.


The next step is to "Complete the migration from a 4xx or 5xx server."



Complete the migration from a 4xx or 5xx server

This topic describes how to complete the data migration from your 4xx or 5xx server to the new target server. Before you begin these tasks, be sure you have completed the necessary "Prepare for the migration from a 4xx or 5xx server" on page 9.

If your target server is set up and is running with only the Licensed Internal Code and the operating system (OS/400^(R)) installed (feature code 0205), you can begin at step 1 in this procedure. If you did not

get a new server with feature code 0205, follow steps 1 through 31 in the topic, Restoring previous release user data to a new system: Step-by-step instructions in Chapter 14 of the Backup and Recovery

Guide  to install the Licensed Internal Code and OS/400 on the target server. When you have completed these steps, continue with step 8 in this topic.

1. Sign on to the target server as user QSECOFR. You do not need to enter a password at this time.
2. At the IPL Options screen, enter the correct date and time. Verify that the following values are set as follows:
 - Start to system to restricted state = Y
 - Define or change system at IPL = Y
 - Set major system options = Y
3. On the Set Major System Options screen, select **N** to not enable automatic configuration.
4. On the Define or Change the System at IPL screen, do the following:
 - a. Select option 3 (System value commands).
 - b. On the System Value Commands screen, select option 3 (Work with System Values).
 - c. On the Work with System Values screen, type 2 next to the following system values:
 - Change QALWOBJRST to *ALL
 - Change QIPLTYPE to 2
 - Change QJOBMSGQFL to *PRTWRAP
 - Change QJOBMSGQMX to a minimum of 30
 - Change QPFRADJ to 2
 - Change QVfyOBJRST to 1
 - d. After the system changed the system values, press F3 twice to return to the Define or Change the System at IPL screen
5. On the Define or Change the System at IPL screen, press F3 to exit and continue the IPL.
6. On the Change Password screen, type QSECOFR as the current password. Enter a new password. Re-enter the password to verify and press Enter.
7. Perform steps 25 through 31 in the topic, Restoring previous release user data to a new system: Step-by-step instructions in Chapter 14 of the Backup and Recovery Guide  .
8. If a controller or device no longer has a valid resource on the system, follow the steps in fix hardware resource names after an upgrade to make the necessary corrections.
9. Install any new licensed programs (LPs).
10. Follow the steps in Install, upgrade, or delete OS/400 and related software  .
11. Use the Add Job Schedule Entry (ADDJOBSCDE) command and the information you printed from your source server to add job scheduler entries.
12. If you have remote database directories, locate the printout of your remote database directory entries from your source server. For each entry on the list, use the Add Remote Database Directory Entry (ADDRDBDIRE) command to add the entry.
13. If you installed Windows^(R) Server for iSeries^(TM) on your server and you saved your server with the Integrated xSeries^(R) Server in a Varied off setting, follow these steps:
 - a. Add the links for the server descriptions. Enter the following for each server description:
ADDNWSSTGL NWSSTG (storage_name) NWS(server_description)
 - b. Vary on your Integrated xSeries Server by entering WRKCFGSTS *NWS and selecting option 1 to vary on each server.
14. Print your server configuration information as follows:
 - a. On the OS/400 command line, enter PRTSYSINF and then print the resulting spooled file. This prints reports of the hardware resources, software resources, system values, installed fixes (program temporary fixes or PTFs), and other configuration information.

- b. Print a new system configuration list and keep this list for future reference.
 - c. On the OS/400 command line, enter WRKDEVD. Use option 6 to print the device descriptions.
 - d. On the OS/400 command line, enter WRKCTLD. Use option 6 to print the controller descriptions.
 - e. If you have a partitioned server, print the system configuration for logical partitions.
15. Save the entire server using option 21 of the GO SAVE command. Make sure that you specify the following options:
- a. Vary off the network server...*ALL
 - b. Unmount file systems.....Y
- Note:** It is recommended that you have two copies of the backup media.
16. Resume normal operations and verify that all your applications run properly.
17. Tune the server performance.
This ensures that your servers make the best use of the system resources, and allows workloads to run as efficiently as possible.

Scenarios: Data migration

This topic contains a number of data migration scenarios. Use these scenarios to help you become familiar with the details involved with migrating your data to another server.

Data migration scenario 1: Migrating from V4R5 on a 620 to V5R3 on an 520 server

In this scenario, you have a 620 server, you are running V4R5, and you want to migrate your data to a 520 server.

What to do:

You cannot install OS/400^(R) V5R3 on your 620 server. To migrate your data, you will save the data to a tape drive that is compatible with the 520 and then restore the data on the 520.

To perform this data migration, first “Prepare for the migration from a 4xx or 5xx server” on page 9, then “Complete the migration from a 4xx or 5xx server” on page 10.

Data migration scenario 2: Migrating from V4R5 on a 740 to V5R3 on a partitioned 570 server

In this scenario, you have a 740 server, you are running V4R5, and you want to migrate your data to a partitioned 570 server.

What to do:

You can install OS/400 V5R3 on your 740 server. To migrate your data, you will first install V5R3 on your 740 server, then save the data to a tape drive that is compatible with the partitioned 570 and restore the data on the 570.

To perform this data migration, first “Prepare for the migration” on page 7, then “Complete the migration” on page 8.

Data migration scenario 3: Migrating from V5R1 on a partitioned 830 server to V5R3 on an 825 server

In this scenario, you have an 830 server with multiple V5R1 partitions, and you want to migrate your data to an 825 server.

What to do:

You can install OS/400 V5R3 on your 825 server. To migrate your data, you will first install V5R3 on all partitions of your 830 server, then save the data from each partition to a tape drive that is compatible with the 825 and restore the data on the 825.

To perform this data migration, first “Prepare for the migration” on page 7, then “Complete the migration” on page 8.

Data migration scenario 4: Installing a new version of OS/400 on your server

In this scenario, you are running V4R5, V5R1, or V5R2 on your server and you want to upgrade to V5R3.

What to do:

If you are installing a new version of OS/400 on the same server, it is not necessary to perform an explicit data migration. You can use the Install the OS/400 release topic to install V5R3 on your server.

Data migration scenario 5: Upgrading your server to an 890 server

In this scenario, you want to upgrade to the new 890 server.

What to do:

If you are upgrading to a new iSeries^(TM) server without changing the serial number, it is not necessary to perform an explicit data migration. You can use the Upgrades topic.

Data migration scenario 6: Migrating data from one partition to another

In this scenario, you want to migrate data from one partition to another on your server.

What to do:

If you are migrating data from one iSeries server partition to another partition on the same server, follow the instructions for Restoring a Logical Partition to Another Logical Partition—Checklist 22 in Chapter 4

of Backup and Recovery Guide .

Troubleshoot the data migration

This topic contains information related to some data migration-specific problems that may occur. In many cases, the time you spend planning for the data migration, and performing the data migration according to instructions can prevent these problems from occurring.

- SRC A900 2000 appears on the control panel display of the server.
This SRC appears if the QIPLTYPE is set to 2 or if there is no device description for the console display. This SRC and message are normal during the data migration procedure. The SRC will disappear when you perform a normal IPL. If no workstation on your server is operational when you receive SRC A900 2000, call your service provider.
- You see Message ID CPF3717: File not selected. File label or file name mismatch for file *filename*.
This type of message occurs most frequently when the incorrect tape is inserted into the tape drive or when you have incorrect parameters for the RESTORE command.
- Job scheduler entries are not restored on the target server when you migrate from a 4xx or 5xx server.
You must manually re-create the job scheduler entries on the target server. If you did not print these entries before you migrated your data, you can get them from the source server.
- The target server cannot read the tapes you used to save the data from your source server.
Save the data from a source server using a tape drive that is compatible with the target server.
- You cannot configure your twinaxial devices.
If you are using a twinaxial console on the source server and using Operations Console on the target server, you must have a twinaxial controller for any twinaxial devices you plan to run from the target server.

For more information, see the preventive service planning (PSP) document. The PSP document for V5R3 data migrations is SF98167. This PSP document describes High-Impact and PERvasive (HIPER) problems.
